ORDINANCE NO. 2024-07

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 123
“SCHEDULE OF FEES” OF THE CODE OF THE BOROUGH OF LEONIA, SECTION
123-6 “DOG AND CAT LICENSES” (CHAPTERS 88 AND 297)**

WHEREAS, the Mayor and Council of the Borough of Leonia believe it is in the best interests of the Borough to amend the Fee Ordinance.

BE IT ORDAINED by the Mayor and Council of the Borough of Leonia, County of Bergen, State of New Jersey, as follows:

Section 1.

Chapter 123 “Schedule of Fees”, Section 123-6 of the Code of the Borough of Leonia is amended and supplemented as follows:

123-6 Dog (Chapter 88) and Cat (Chapter 297) License

Dog License

- (a) License and registration tag for each sterilized dog licenses: \$12 per year or \$30 for a three-year license.
- (b) License and registration tag for each non-sterilized dog licensed: \$21 per year or \$63 for a three-year license.
- (c) Late fee: an additional \$10 from March 1 through December 31.

Cat License

- (d) \$12 per year for each sterilized cat licensed or \$30 for a three-year license.
- (e) \$21 per year for each non-sterilized cat licensed or \$63 for a three-year license.
- (f) Late fee: an additional \$10 from March 1 through December 31.

Section 2.

Should any section, part or provision of this ordinance be held unconstitutional or invalid, such decision shall not affect the validity of this ordinance as a whole, or any other part thereof.

Section 3.


All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
