Local Law 2 of 2024
Chapter 36-6 Procedure for Requests

- A. All requests for records, more specifically requests governed by the New York Freedom of Information Law ("FOIL"), must be written and submitted either:
 - a. Online through the Town of LeRay's Municipal Website via the "FOIL Request Submission Portal"; or
 - b. To the Town Clerk at the Town Municipal Office.

- B. All FOIL requests must reasonably describe the record or records sought. Whenever possible, a person requesting records should supply information regarding dates, file designations, and/or any other information that may help describe the records sought.

- C. The Town shall send a response to any complete FOIL request within five (5) business days of receipt of the request.

- D. If the records access officer does not provide or deny access to the record sought within five (5) business days of receipt of a request, he or she shall furnish a written acknowledgment of receipt of the request and a statement of the approximate date when the request will be granted or denied.
