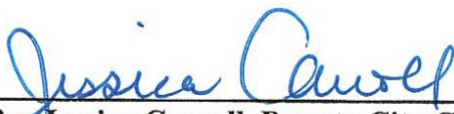

RESOLUTION NO. 26-06-01-60

A RESOLUTION AUTHORIZING THE DEPUTY CITY CLERK TO EXECUTE DOCUMENTS IN THE ABSENCE OF THE CLERK

WHEREAS, the Illinois Municipal Code Section 3.1-35-95 provides that a Deputy City Clerk may execute documents in the absence of the City Clerk; and

WHEREAS, it is in the best interest of the citizens of Le Roy to authorize the Deputy City Clerk to execute documents in the absence of the City Clerk.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS, as follows:

Section 1: The Deputy Clerk may execute all documents required by law to be executed by the Municipal Clerk and may affix the seal of the Clerk wherever required on all documents whenever the Municipal Clerk is temporarily or permanently incapacitated to perform those functions and duties. Such incapacity may be caused by absence for any reason, including vacation, business purposes, health or other reasons.

Section 2: The Deputy Clerk may execute all documents required by law to be executed by the Municipal Clerk and may affix the seal of the Clerk wherever directed to do so by the Municipal Clerk.

Section 3: In signing any document, a Deputy Clerk shall sign the name of the Clerk followed with the word "By" and the Deputy Clerk's own name and the words "Deputy Clerk".

Section 4: This Resolution shall be in full force and effect from and after its approval and publication as required by law.

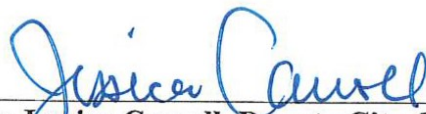

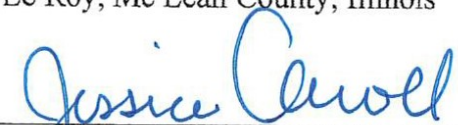

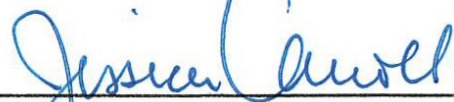
