A local law to allow the Code Enforcement Officer, Acting Code Enforcement Officer and other Code Enforcement Officers to reside anywhere in Sullivan County.

1. **Purpose:** The Village of Liberty Village Board has found that there is a dearth of persons eligible and qualified to be Code Enforcement Officers who live in the Village of Liberty or who are willing to live in the Village of Liberty. In order to increase the pool of potential Code Enforcement Officers, the Village of Liberty Village Board desires to enact a Local Law pursuant to Village Law § 3-300(2) to change the residency requirement set forth in Village Law § 3-300 that a duly elected or appointed officer of the Village of Liberty (which includes a Code Enforcement Officer) reside in the Village of Liberty, so that a Code Enforcement Officer (Village of Liberty Village Code § 14-1), Acting Code Enforcement Officer (Village of Liberty Village Code § 14-2), or other Code Enforcement Officer (Village of Liberty Village Code § 14-3) may reside anywhere in Sullivan County.
2. A new Section 14-3.A of the Village Code of the Village of Liberty is hereby enacted to read as follows:

“§ 14-3.A Residency.

“The Code Enforcement Officer (Village of Liberty Village Code § 14-1), Acting Code Enforcement Officer (Village of Liberty Village Code § 14-2) or other Code Enforcement Officer (Village of Liberty Village Code § 14-3) shall reside in the County of Sullivan.”

3. This Local Law shall take effect immediately upon its filing with the Department of State.
