ORDINANCE NO. 1628-16-24

A CAPITAL ORDINANCE APPROPRIATING THE SUM OF \$222,828 FOR ACQUISITION OF VARIOUS VEHICLES, EQUIPMENT AND IMPROVEMENTS TO BE UNDERTAKEN BY THE BOROUGH OF LITTLE FERRY AND TO APPROPRIATE \$222,828 FROM CAPITAL IMPROVEMENT FUND.

<u>BE IT ORDAINED</u>, by the Borough Council of the Borough of Little Ferry in the County of Bergen, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

<u>SECTION 1.</u> The improvements described in Section 2 of this Ordinance are hereby respectively authorized as general improvements to be made by the Borough of Little Ferry, New Jersey, for the said improvements or purposes stated in Section 2, there is hereby appropriated the sum of money therein stated as the appropriation made for said improvements or purposes, said sum being inclusive of all appropriations herefore made thereof and amounting in the aggregate to \$222,828 which is now available in capital improvement fund.

<u>SECTION 2.</u> The Borough of Little Ferry, in the County of Bergen, State of New Jersey, is hereby authorized to provide for the following:

Capital Improvement Fund:

Acquisition of (1) Excavator and appurtenances	90,000
Repairs to Public Buildings	80,000
Acquisition of Fire Department Bailout Equipment	11,242
Acquisition of Radio Equipment for the Fire Department	<u>41,586</u>

Total Appropriation and Estimated Costs \$222,828

SECTION 3. It is hereby determined and stated:

- (a) That said purposes are not a current expense. That the same are improvements which the municipality may lawfully make and that no part of the cost of said improvements has been or shall be specifically assessed on properties specifically benefited.
- (b) It is not necessary to finance said appropriations by the issuance of obligations by the Borough of Little Ferry pursuant to the Local Bond Law of the State of New Jersey, for the reason that monies sufficient to cover the appropriations thereof shall be available from capital improvement fund in the amount of \$222,828.

<u>SECTION 4.</u> The Capital Budget of the Borough of Little Ferry is hereby amended or established to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing all detail of the amended or temporary Capital Budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available for public inspection.

<u>SECTION 5.</u> The sum of \$222,828 is hereby appropriated for the aforementioned purposes.

<u>SECTION 6.</u> It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said appropriations, since the gross debt of the municipality, as defined under the Local Bond Law, is not increased by this Ordinance and no obligations in the matter of notes or bonds are authorized by this Ordinance.

<u>SECTION 7.</u> This Ordinance shall take effect after publication thereof and final passage as required by law.
