APPROPRIATION ORDINANCE

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH LEM ENTERPRISES OF FAYETTEVILLE, ARKANSAS FOR THE REPAIR OF A SKIDSTEER, DISPENSING WITH COMPETITIVE BIDDING AS NOT NECESSARY AND FOR OTHER PURPOSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LINCOLN, ARKANSAS, THAT:

<u>Section One: Title.</u> This Ordinance shall be known as an Ordinance Authorizing the Mayor to Enter into a Contract with Lem Enterprises of Fayetteville, Arkansas for the Repair of a Skidsteer, Dispensing with Competitive Bidding as Not Necessary and for Other Purposes.

Section Two: Findings. The Lincoln City Council finds as follows:

a. The City has a skidsteer that requires repairs.

b. LEM Enterprises of Fayetteville, Arkansas, has presented the City with an acceptable contract for the skidsteer repairs for a total contract price of \$4,480.00.

Section Three: Competitive Bidding Not Necessary. Based on the Council's findings above, the Council hereby declares that competitive bidding is not necessary in these circumstances, and therefore waives the requirement for competitive bidding in accordance with ARK. CODE ANN. § 14-58-303(b)(1)(A) and LINC. MUNI. CODE § 3.04.01.

<u>Section Four:</u> <u>Appropriation</u> he City Council hereby appropriates the sum of FOUR THOUSAND, FOUR HUNDRED EIGHTY and NO/100 DOLLARS (\$4,480.00) from the Water Utility Budget for the purchase authorized by this Ordinance. To the extent the City of Lincoln's 2024 Budget requires an amendment to complete this purchase, the Budget is hereby so amended.

<u>Section Five:</u> <u>Contract Authorized.</u> The Mayor is hereby authorized to enter into a contract with LEM Enterprises for the repairst as stated above.

<u>Section Six: Votes Required, Readings, Effective Date.</u> This is an Appropriation Ordinance. In accordance with ARK. CODE ANN. § 14-55-204 and ARK. CODE ANN. § 14-55-203(c)(2), this ordinance is not an ordinance of a general or permanent nature. As such, it requires only a simple majority of votes of the City Council to pass and does not require three separate readings. This ordinance is effective immediately upon its passage.
