**BOND ORDINANCE AMENDING BOND ORDINANCE  
NUMBER 66-48 FINALLY ADOPTED BY THE CITY  
COUNCIL OF THE CITY OF LINDEN, NEW JERSEY ON  
JULY 19, 2022**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LINDEN, IN THE COUNTY OF UNION, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The Bond Ordinance of the City Council of the City of Linden, in the County of Union, New Jersey (the "City") entitled "Bond Ordinance Providing An Appropriation Of \$902,000 For City Hall Chiller Plant Replacement For The Division Of Buildings And Grounds For And By The City Of Linden, In The County Of Union, New Jersey And Authorizing The Issuance Of \$856,900 Bonds Or Notes Of The City For Financing Part Of The Appropriation" finally adopted on July 19, 2022 (the "Ordinance") is hereby incorporated by reference in its entirety.

Section 2. The Ordinance is hereby amended by (a) deleting the reference of "\$902,000" for the appropriation and estimated cost and "\$856,900" for the estimated maximum amount of bonds or notes and substituting in lieu thereof "\$1,252,000" and "\$1,189,400," respectively; and by (b) deleting the reference to "\$45,100" for the down payment required by the Local Bond Law and substituting in lieu thereof "\$62,600.

This Ordinance is hereby further amended in Section 3(a) by adding after the phrase "for City Hall Chiller Plant replacement" the phrase "and roof improvements in connection with the installation".

Section 3. The capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolutions in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. This Section 4 constitutes a declaration of official intent under Treasury Regulation Section 1.150-2. The City reasonably expects to pay expenditures with respect to the Improvements prior to the date that the City incurs debt obligations under this Bond Ordinance. The City reasonably expects to reimburse such expenditures with the proceeds of debt to be incurred by the City under this Bond Ordinance. The maximum principal amount of debt expected to be issued for payment of the costs of the Improvements is \$1,189,400.

Section 5. All other provisions of the Ordinance shall remain unchanged.

Section 6. This amendatory bond ordinance shall take effect twenty days after the first publication thereof after final adoption as provided by Local Bond Law.
