AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER VII, TRAFFIC, OF AN ORDINANCE ENTITLED, "AN ORDINANCE ADOPTING AND ENACTING THE REVISED GENERAL ORDINANCES OF THE CITY OF LINDEN, 1999," PASSED NOVEMBER 23, 1999 AND APPROVED NOVEMBER 24, 1999, AND AS AMENDED AND SUPPLEMENTED

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LINDEN:

Section 1. That Chapter VII, Traffic, shall be and the same is hereby amended as follows:

Chapter VII, Traffic

7-33 HANDICAPPED PARKING REGULATIONS

7-33.1A Handicapped Parking On-Street

921 East Henry Street	1	On the northwesterly sideline of East Henry Street, 218 feet more or less southwesterly from the projection of the southwesterly curblineline of Carnegie Street in front of 921 East Henry Street for a length of 22 feet. The aforesaid space is specifically reserved and designated for a vehicle for Jansen Demesmin to be identified by license plate number and placard to be issued by the City, and no other vehicle bearing or displaying handicapped license plates and/or placards, or not, shall be permitted to park in such space.
203 West 16th Street	1	On the southeasterly sideline of West 16th Street, 151 feet more or less northeasterly from the projection of the northeasterly curblineline of Mopsick Avenue in front of 203 West 16 th Street for a length of 22 feet. The aforesaid space is specifically reserved and designated for a vehicle for Emma Gothie to be identified by license plate number and placard to be issued by the City, and no other vehicle bearing or displaying handicapped license plates and/or placards, or not, shall be permitted to park in such space.
1908 East St Georges Avenue	1	On the southeasterly sideline of East St Georges Avenue, 105 feet more or less northeasterly from the projection of the northeasterly curblineline of Adams Street Avenue in front of 1908 East St Georges Avenue for a length of 22 feet. The aforesaid space is specifically reserved and designated for a vehicle for Love P. Disanto to be identified by license plate number and placard to be issued by the City, and no other vehicle bearing or displaying handicapped license plates and/or placards, or not, shall be permitted to park in such space.

ADD (continued):

508 Ziegler Avenue

1

On the southeasterly sideline of Ziegler Avenue, 92 feet more or less northeasterly from the projection of the northeasterly curblineline of Maple Avenue in front of 508 Ziegler Avenue for a length of 22 feet. The aforesaid space is specifically reserved and designated for a vehicle for Stanley Seibert to be identified by license plate number and placard to be issued by the City, and no other vehicle bearing or displaying handicapped license plates and/or placards, or not, shall be permitted to park in such space.

Section 2. The remaining provisions of the Chapter hereby amended and supplemented shall continue in full force and effect to the same extent as if herein fully repeated.

Section 3. If any section, subsection, provision, clause, or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such adjudication shall not affect the remaining sections, subsections, provisions, clauses, or portions, which shall be deemed severable therefrom.

Section 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 5. This Ordinance shall take effect in the manner provided by law.
