

LOCAL LAW 3 – 2024

A LOCAL LAW TO AMEND THE ZONING MAP OF THE TOWN OF LLOYD AT 11 WEEDS MILL ROAD (SBL 87.2-1-10) FROM R 1/2 (RESIDENTIAL 1/2 ACRES) TO GB (GENERAL BUSINESS)

SECTION ONE. PURPOSE.

The purpose of this local law shall be to amend the Zoning Map of the Town of Lloyd.

SECTION TWO. MAP AMENDMENT.

The official Zoning Map of the Town of Lloyd on file in the office of the Town Clerk is hereby amended as follows:
