(2) Tree services, which includes tree removal, pruning, trimming and stump grinding, shall only be performed in the Village by a licensed tree service contractor or property owner on the following days and times, excluding federal and New York State holidays:

- (a) Permitted hours of operation for tree services:
 - [1] Property owner:
 - [a] 8:00 a.m. to 6:00 p.m. on Monday through Friday.
 - [b] Prohibited on Saturday.
 - [c] Prohibited on Sunday.
 - [2] Tree service contractor:
 - [a] 8:00 a.m. to 6:00 p.m., Monday through Friday.
 - [b] Prohibited on Saturday.
 - [c] Prohibited on Sunday.
