AN ORDINANCE TO AMEND CHAPTER 119 ENTITLED "FIRE PREVENTION" OF THE CODE OF THE TOWNSHIP OF LOPATCONG, WARREN COUNTY, NEW JERSEY TO INCREASE THE APPLICATIONS AND REGISTRATION FEES

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the Council of the Township of Lopatcong, County of Warren and State of New Jersey that Chapter 119 entitled "Fire Prevention" be amended as follows:

Section 1:

119-09. Permit Fees.

B. the application fee for a certificate of smoke detector and carbon monoxide alarm compliance (CSDCMAC), as required by N.J.A.C. 5:70-2.3, shall be in accordance with the following fees schedule:

(1) Requests for CSDCMAC received more than 10 business days prior to the change of occupancy: \$75.00

(2) Requests for a CSDCMAC received four to 10 business days prior to the change of occupancy: \$125.00

(3) Requests for a CSDCMAC received a fewer than four business days prior to the change of occupancy: \$175.00

119-10. Non-Life-Hazard Uses.

In addition to the registration required by the Uniform Fire Code, the following Non-Life Hazard Uses shall register with the Fire Prevention Bureau. These uses shall have cyclical inspection, at a frequency not less than once a year every twenty-four (24) months and shall pay an annual registration fee as follows:

Section 2:

All sections of the Chapter that are unchanged shall remain as is.

Section 3:

Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 4:

Repealer. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 5:

Effective Date. This Ordinance shall take effect upon final passage and publication as provided by law.
