

Ordinance No. 2023-08

AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LOPATCONG,  
COUNTY OF WARREN AND STATE OF NEW JERSEY AMENDING AND  
SUPPLEMENTING CHAPTER 115 ENTITLED "FEES" OF THE TOWNSHIP CODE TO  
INCREASE CERTAIN FEES PRONOUNCED UNDER SAID CHAPTER

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Township Council of the Township of Lopatcong, County of Warren and State of New Jersey that Chapter 115 entitled "Fees" be amended as follows:

Section 1:

Article III Reimbursement Fees for Returned Checks

115.11. Items returned for insufficient funds.

In the event that a check is returned for insufficient funds, the Township may charge the person a fee of fifty dollars (\$50.00) for each returned check.

Article IV Permits

115.13. Brush Pick Up Permit

The following are the charges for each brush pick up permit issued by the Township:

Senior Citizens – Age 62 and older – Fifty Dollars (\$50.00) per pick up;

Resident – Seventy-Five dollars (\$75.00) per pick up.

Section 2:

All sections of the Chapter that are unchanged shall remain as is.

Section 3:

Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 4:

Repealer. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 5:

Effective Date. This Ordinance shall take effect upon final passage and publication as provided by law.
