AN ORDINANCE, To Amend the Code of the Township of Lower Merion, Chapter A180, Historic Resource Inventory, To Improve Consistency With The Township's Official Address Listing, To Modify The Addresses Of Historic Resources At Maybrook To Improve Consistency With The Township's Official Address Listing And Clarify The Designated Historic Elements, To Assign New ID Numbers To Addresses Created By Adaptation Of Existing Historic Resources The As Condominiums, To Add The Park In The Gladwyne Historic District, To Upgrade The Historic Mill Ruin On Mill Creek Road From Class 2 To Class 1, To Remove Addresses Where Historic Elements Have Been Demolished And None Remain, To Add Resources In The Harriton Farm Development, To Add Historic Resources As Previously Approved But Not Adopted Via Ordinance, And To Correct Property Addresses **Erroneously Assigned To Adjacent Parcels.**

The Board of Commissioners of the Township of Lower Merion does hereby enact and ordain:

Section 10. Nothing in this Ordinance or in Chapter A180 of the Code of the Township of Lower Merion, as hereby amended, shall be construed to affect any suit or proceedings in any Court, any rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under the said Chapter A180 prior to the adoption of this amendment.

Section 11. The provisions of this Ordinance are severable, and if any section, sentence, clause, part, or provision thereof shall be held illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such decision of this court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this ordinance. It is hereby declared to be the intent of the Board that this ordinance would have been adopted if such illegal, invalid, or unconstitutional section, sentence, clause, part, or provision had not been included herein.

Section 12. This Ordinance shall take effect and be in force from and after its approval as required by law.
