ORDINANCE 2024-02 (Duly Adopted: September 19, 2024)

AN ORDINANCE ACCEPTING CERTAIN ROADWAYS INTO THE OFFICIAL ROAD NETWORK OF LOWER MACUNGIE TOWNSHIP FOR LIQUID FUELS REIMBURSEMENT ONLY, AS DEPICTED ON THE ENCLOSED PLAN AND TABULATION

WHEREAS, the Board of Commissioners of Lower Macungie Township approved various subdivisions and land development plans; and

WHEREAS, in conjunction with said developments, the developers thereof agreed to create, lay out and improve to the Township standards certain roadways shown on the land development plans; and

WHEREAS, the developers have, in fact, created, laid out and improved said roadways, which the Township has duly inspected and determined to be acceptable for application for liquid fuels reimbursement; and

WHEREAS, in accordance with the Municipalities Planning Code, and the First Class Township Code, the Board of Commissioners of Lower Macungie Township has agreed to a accept said roadways into the road system of Lower Macungie Township, and vacate portions of other roadways, for purposes of liquid fuels reimbursement only; and

WHEREAS, the developers have, in fact, previously deeded and recorded descriptions of the roadway right-of-way areas.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Commissioners of Lower Macungie Township, County of Lehigh, Commonwealth of Pennsylvania, that the Official Liquid Fuels Map of Lower Macungie Township is hereby amended as follows:

ARTICLE I Acceptance and Vacation of Roadways

Lower Macungie Township, having received an offer of dedication of said roadways, does hereby accept the roadways as depicted on the enclosed plan entitled "Lower Macungie Township Liquid Fuels Map," dated August 22, 2024 and identified as Exhibit "A," and listed on the enclosed tabulation entitled "Lower Macungie Township 2024 Liquid Fuels Road Modifications" and identified as Exhibit "B," submitted in 2024 for inclusion in 2025 distribution, and consisting of 0.61 linear miles of roads into the official road system of Lower Macungie Township for liquid fuels reimbursement purposes only.

ARTICLE II Severability

If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Board of Commissioners of Lower Macungie Township that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.

ARTICLE III Repealer

All ordinances, resolutions, or parts thereof which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

ARTICLE IV Effective Date

This Ordinance shall become effective one (1) day after enactment or upon recordation of this Ordinance within the Township's official Ordinance Book, whichever comes later.


