

ORDINANCE 23-04C

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED, "CODE OF THE TOWNSHIP OF LONG BEACH, COUNTY OF OCEAN, STATE OF NEW JERSEY, (1997)" IN CHAPTER 128, WHICH PERTAINS TO OUTDOOR LIGHTING

STATEMENT OF PURPOSE

The purpose of the Ordinance is to amend Chapter 128 to revise the regulations relating to outdoor lighting.

SECTION I

§128-3E is added as follows.

- E. All roof deck and balcony lighting shall be installed, placed, and/or affixed to the deck no higher than the guard railing height and the lighting source shall be directed downward towards the deck or balcony or otherwise shielded to prevent the light from being directed onto neighboring properties. No lighting source on any roof deck or balcony shall be directed towards or shine on neighboring properties.

SECTION II

All Ordinances or parts of Ordinance inconsistent herewith are repealed to the extent of such inconsistency.

SECTION III

If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION IV

This Ordinance shall take effect upon publication thereof after final passage according to law.

Effective date.

This ordinance shall take effect after final adoption and publication as required by law.
