ASBURY PARK, April 6.—The Johnson-Fleming dope case which, according to intimations by Assistant Prosecutor J. Victor Carton is taking on the aspect of a conspiracy, will be taken under advisement today by the Monmouth County grand jury sitting in special session at Freehold.

The grand panel began the hearing of witnesses in the case shortly after noon on Wednesday, when it heard testimony by Capt. Detective Edward Burke, Magistrate William E. Andrew, Jr., Federal Agent Max Roder, Abram Blakely, chemist, in the Narcotic Laboratory in Philadelphia; George Fleming, colored, on whose affidavit Johnson was arrested; Harold M. Canning, an employee of the Asbury Park Press; and Israel Goldman, Long Branch pharmacist.

At today's session the grand jury has in readiness to hear: Wayne D. McMurray, manager of the Asbury Park Press; Edward Banker, assistant police magistrate; Martin "Micky" Stein, Springfield Avenue saloon keeper; Mrs. Marie Saunders, colored, associate of Stein's in the Willing Workers Association, a West Side political group; Constable John Burke, brother of the detective; Gavino Siciliano, also a constable; Gavino Gatta, Peter Montana, William J. Sneider, local merchant; Nathaniel Jones, colored, of Spring Lake.

The injection of Sneider into the picture came as a complete surprise today. It was reported that Sneider would be questioned along lines (Continued on Page Twelve)

Senate Seeks Deletion of Bad, Bitter Words By Long, Clark of Missouri

One Solon Suggests They Adjourn To Prize Fight Ring and "Have It Out"

WASHINGTON, April 6.—(AP)—Senators sought today to blot from the books the hard words that Huey P. Long gave and took yesterday.

The move to expunge the violent quarrel from the record was based on contentions that it was irrelevant and personal.

The stocky, rough and tumble senator from Louisiana and the tall, slender Senator Harrison of Mississippi were due to meet again today across a committee table and observers braced themselves for another explosion.

Their head-on collision yesterday—a violent impact which drew other Democrats into the row—was called as bitter and personal a fight as had occurred between two Senators in a long time.

Once Senator Hastings (R., Del.) rose to interrupt: "Gentlemen, I wonder if we can't adjourn to some prize fight ring and have it out."

Long, displeased at happenings before the finance committee, of which Harrison is chairman, swung into action. He started flinging taunts at the Mississippi veteran because of his opposition to Long's "share the wealth" ideas of taxation. Then Senator Clark, Missouri Democrat, took potshots at Long.

Here are some sample remarks: Clark: "There is no more connection between the very important revenue bill before the Senate and this seven-hour harangue than there is between the best thing to do for recovery of the United (Continued on Page Twelve)

M'CAMPBELL FLAYS N. J. GOVERNMENT

Tells M. J. C. Students It Is Most Corrupt In English-Speaking World

Assemblyman Theron McCampbell has no rosy illusions about becoming Governor of New Jersey but if he does the state will have a new constitution within three months. The farmer-legislator from Holmdel made that confidential disclosure yesterday afternoon to 400 students of Monmouth Junior College at the same time he was denouncing New Jersey's government as the most corrupt in the English-speaking world, expressing his views on national and world economic conditions and finding some faults in present day education.

The Monmouth assemblyman visited the college at Long Branch High School as the guest of County Superintendent of Schools William M. Smith, climaxing a tour of inspection with his address in the school auditorium.

In sharp contrast to his usual fiery manner of speaking, Assemblyman McCampbell, who has announced his independent candidacy for the Democratic gubernatorial nomination, opened his address by speaking intimately of his own youth and education. He told the students they were exceedingly fortunate to have the opportunities offered them but in the next (Continued on Page Twelve)

COURT CONSIDERS PLEA TO SET ASIDE FEARGE CONVICTION

Counsel For Convicted Murderer Charges Eight Errors Were Made By Judge Truax

MENTION OF REPUTATION OF DEFENDANT IS QUOTED

Defense Also Objects To Mention Of Character Witness Importance

TRENTON, April 6.—(AP)—The court of errors and appeals took under advisement yesterday arguments to set aside the conviction of David Pearce, convicted of killing Roy W. Potts, Asbury Park hotel manager.

Charles H. Walker, counsel for Pearce, charged that eight errors were made in the charge to the jury by Judge Harry Truax in Monmouth County over and termier court.

Objections included reference by the judge to the jury to securing a law firm to defend Pearce, also stating that the case depended upon the previous reputation of Pearce, and to asserting that the jury could, from the character witness alone, decide whether a reasonable doubt of guilt had been created.

Other objections by Walker were that Judge Truax had "told the jury he believed the accused guilty of the murder of Potts," and that he "attempted" to tell the jury what his opinion is and what conclusion he has drawn from the testimony.

J. Victor Carton, Monmouth assistant prosecutor, waived his right for oral argument and presented his brief to the court.

He contended that the judge's charges did not prejudice the defendant and denied errors of law charged.

Potts, manager of the Strand Hotel and cafeteria, was shot during a holdup Sept. 5, 1931. Pearce was convicted of murder in the first degree with recommendation for life imprisonment the following July 15.

Mrs. Massie Again Attempts Suicide On Liner Roma

GENOA, Italy, April 6.—(AP)—Ship's officers of the S. S. Roma said today that Mrs. Thalia Fortescue Massie, principal figure in the sensational Honolulu assault case of 1932, attempted suicide by slashing her wrist and throwing herself from the liner's top deck on the voyage from New York.

Prof. Dario Borelli, director of the Nervous Ailments Clinic in Genoa where Mrs. Massie has been taken since the ship's arrival yesterday, confirmed the officer's report.

The director said that Mrs. Massie told him she attempted suicide when the steamer was three days out from Genoa because:

BLOOD-SPATTERED CAR OF CARTERET COUSINS DISCOVERED

Pond To Be Drained In Search For Bodies Of Edward, Sigmund Schwartz

POLICE THINK PAIR WERE TAKEN FOR RIDE

Motive May Lie In Prohibition Era Bootleg Dealings

CARTERET, April 6.—(AP)—Police, holding to their double murder theory, today waited for a large pond to be drained to see if it might yield the bodies of Edward and Sigmund Schwartz, missing 30-year-old liquor dealer, and Sigmund Schwartz, 28, his cousin.

The pond, located in a sparsely settled section on the outskirts of town, is not far from the spot where officers found the abandoned, blood-smeared automobile in which the missing men, members of a prominent local family, were last seen.

The words: "Carteret rat," scrawled in the mud on the car, and evidence that a struggle had taken place nearby led police to believe the two men had been taken for a ride and slain. The only motive police advanced for the killings was that they may be connected with Edward Schwartz's liquor dealings which went far back into the prohibition era.

Work on draining the nearby pond was begun last night, and it was expected the task would be finished by noon.

The blood stained auto was discovered shortly before noon yesterday. The two cousins had been missing since they left Edward's liquor store the night before. Police believe they were decoyed to their deaths while trying to deliver a consignment of liquor, falsely ordered by telephone for a customer living in a lonely section of town.

TERMED PYROMANIAC; ADMITS 2 OTHER FIRES

Gives No Reason For Them; To Be Grilled On Other Recent Blazes

BRADLEY BEACH, April 6.—Working on a "hunch" Patrolman Harvey Gaunt kept a secret vigil over the two and a half story frame dwelling at 307 Brinley Street last night and was rewarded at 10 o'clock when he reported he caught Harry Woodward, 41, of 306 Brinley Street, in the act of firing the house, which had been damaged by two other blazes recently. Questioned at police headquarters until 5 o'clock this morning, Woodward is said to have signed a confession in which he admitted firing the dwelling on the two previous occasions. He could give no reason for his act, however, and police were inclined to the belief he might be a pyromaniac. He is expected to be arraigned before Recorder Joseph E. McGill tonight on a charge of arson.

Aiding Patrolman Gaunt and Lieut. Charles J. Poland in grilling Woodward were County Fire Marshal Charles A. Harvey of Long Branch and George Scherff, special investigator for the National Board of Fire Underwriters, who were called to the scene by local police. The officials were planning to question Woodward further today in an attempt to clear up other suspicious fires here.

Patrolman Gaunt reported he caught Woodward as he entered the dwelling, across from Woodward's own home, and applied a match to (Continued on Page Twelve)

W. L. B. TEACHERS TO GET JANUARY PAY

Action Follows Receipt Of Check For \$1,109 From State Fund

WEST LONG BRANCH, April 6.—Local school teachers, who had not been paid for the past three months learned last night at the meeting of the mayor and members of the local council, that their salaries for January would be paid within a short time.

The paying of the salaries results from the receipt of a check for \$1,109 from the state, drawn from the \$7,000,000 state school fund. The check, made out to the custodian of local school funds will be turned over to the borough council and a voucher drawn by that body to permit the payment of the over-due salaries.

Other business included application to the relief funds administration for \$256.49, to cover a deficit incurred here within the past few months in that department. The passing of the application resulted in controversy, a resident of the borough demanding that the names of the emergency workers be made public. This request was refused, the council pointing out that state regulations forbid the making public of the names of the workers.

GOOD TEACHERS SHOULD BE ABLE TO TELL JOKES, SAYS EDUCATOR

ATLANTIC CITY, April 6.—(AP)—A good, healthy teacher who can tell several new jokes every week and put his classroom in competition with the theatre, is the classroom ideal of Eugene Lies, representative of the National Recreation Association.

Lies, attending the sessions of the American Physical Education Association, today commanded full attention when he said the teacher should be "glowing."

So much interest was aroused that he was asked to expand his theories during a panel discussion. Then he said: "Three things which the teacher should have are a sense of humor, good health and 'liveness.' Every teacher should tell several new jokes each week.

"It's all a part of this thing of making the child want to come back, of making the classroom more attractive to them."

Lies found that while some teachers become dull because they are forced to spend too much time out of school in marking papers and preparing lessons, there are others

who get these routine duties over quickly because they have good health and vitality.

In speaking on "The Leisure Challenges the School," Lies stressed the need of a full program to meet the competition of the movies, so-called humorous magazines and recreation found in the streets.

The school program should include music, art, physical education and other so-called "fills" he said, so that the child develops a many sided interest of the use of his leisure time.

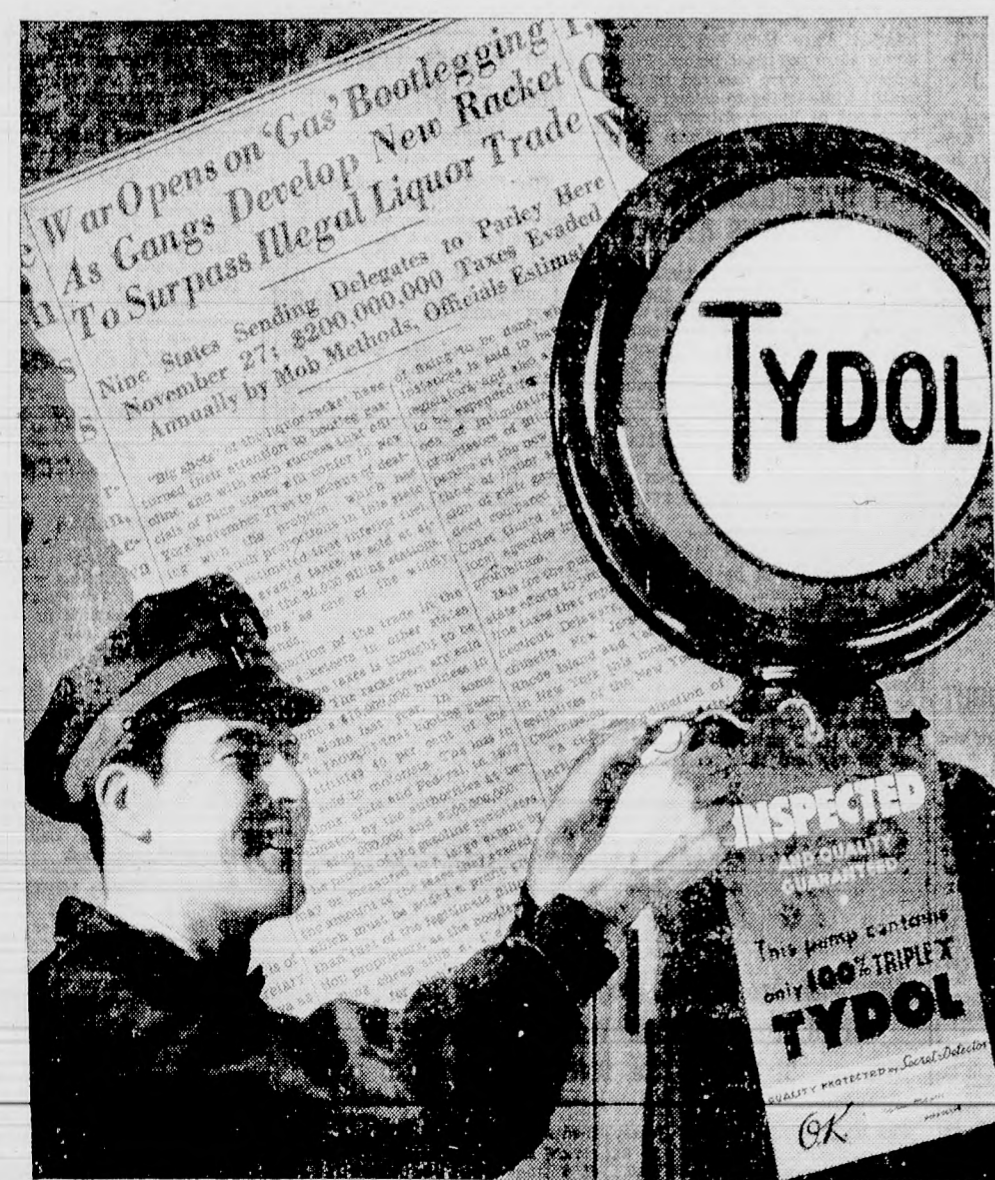

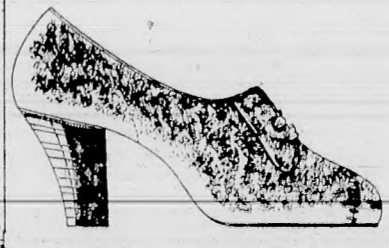

In the suit of Celia Rappolla, Atlantic City, formerly of Long Branch, against Anthony Rappolla, 485 Tabor Street, Long Branch, a continuation was granted to hear additional witnesses. Mr. and Mrs. Rappolla married Nov. 3, 1928, and she charged that the husband left April 15, 1931. They have one child. Extreme cruelty also is charged.

The club met at Legion Hall with Mrs. Rosa Bergen, president, presiding and passed resolutions endorsing the above named candidates. The petitions were circulated by Mrs. Benjamin Andreach, of Keansburg, who was a guest of the local club. The endorsement of Quinn came as a surprise as it had been an almost certain conclusion that the club would endorse Joseph L. Donahay for the post.

Mayor Edward W. Currie addressed the meeting, talking on tax reduction in the borough. He asserted he had carried out his election promises, and declared the tax rate for 1934 would be about \$4 per thousand under the rate of 1933.

FOXWELL RUNS FOR RED BANK MAYOR Warns That Clique Will Rule If Public Fails To Vote In Primary

(By Staff Correspondent) RED BANK, April 6.—Warning that unless the general populace turns out to vote in the coming primaries "a very small group of self-centered and self-interested individuals" will select the candidates, Justice Charles R. D. Foxwell, Democrat, candidate for mayor, today issued a brief statement.

The recent strike at the Eisner factory was mentioned by one of the Foxwell spokesmen present, who declared: "If no one opposed Mayor Charles R. "We must all take a lively interest in and give a serious concern to our public affairs or a very small group of self-centered and self-interested individuals will make this choice for you. Pledging myself to your best interests and to the furthering of your happiness, I shall greatly appreciate the vote and support of my many friends and acquaintances."

The meet will be under the auspices of the National Aeronautic Association of the United States, and for that reason, any records set will be officially recognized.

Although the majority of the entry list will be the primary type gliders, the entrance of several aspirants in the soaring class promises an unusual touch since the latter type gliders remain in the air for hours.

The Lakewood Glider Club, and another in Middletown Township called the Monmouth County Glider Club, will probably uphold the interests of the shore section.

Present plans call for erection of a tent city in one corner of the airport, to house the contestants and club members over the three day period.

Jack Casey, pilot-manager of the airport, said that this field has been selected by the Newark sponsors of the contest as the safest, and in best condition, and also because of its strategic location.

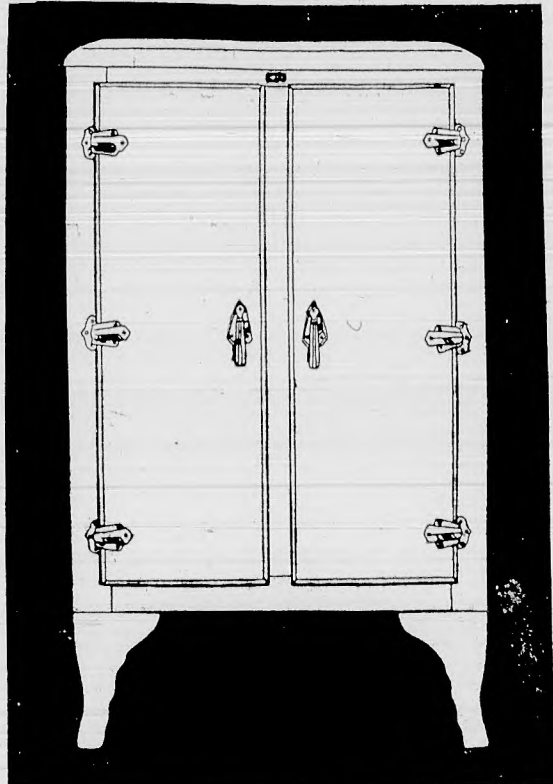

Daily Health Talks
By DR. MORRIS FISHBEIN
Editor, Journal of the American Medical Association, and of Hygiene, the Health Magazine.

The number of notions that people have about health are probably greater and more peculiar than established ideas in any other field.

How many times have you heard the statement made that washing inside and out is the best thing for the human body? Actually the human body is a self-regulating mechanism, and if one takes six to eight glasses of water daily, his intestines get about all the washing they need under ordinary circumstances.

Of course, if you are sick with some type of infection of the lower bowel, you may require special types of washings, but those will have to be picked out by your doctor and perhaps given to you by a competent attendant.

Another notion that has frequently prevailed is the idea that deep breathing exercises early in the morning, preferably taken without any clothes, on in front of an open window, is a certain method of good health.

While it may entertain the neighbors, there is no evidence that it really does bring about any remarkable improvement in health.

It has been pointed out, instead, that long-continued forced carbon dioxide from the blood deep breathing washes out the and in that way may be harmful.

Breathing is also an automatic mechanism and any time we interfere with it, we are likely to be disturbing its actions of a well-regulated machine.

Then there is the notion that a pain in the back means a disease of the kidney. A lot of old-time patent medicine advertisements that used to be prevalent in youth is responsible for maintenance of this idea.

Actually, pain in the back is only rarely associated with a disease of the kidney. Disturbances of these vital organs are more likely to manifest themselves by swelling in various portions of the body and by changes in the excretions, which can be found with laboratory examination.

Finally, there is that old bugaboo, auto-intoxication, presumably the appearance of a coated tongue, headache or a feeling of dullness, according to usual belief, always due to the presence in the bowels of a great deal of putrefying and decaying food material.

Actually, however, the presence of such decaying material is a rather rare occurrence. Most scientific physicians have discarded the word "auto-intoxication."

In health practice there is nothing so important as exact knowledge. Notions and superstitions lead to fears which may be more serious than the many minor disturbances of the human body.

In New York

NEW YORK.—In the matter of social democracy, Harlem is as different from the rest of Gotham as well, as black from white. Maybe there is no other place in the world where money means less, and where such a high premium is put on intellectual and professional attainment.

For example, there is one woman society leader, a college graduate whose husband is doorman at a small hotel off Broadway. And another who herself works as telephone operator in a downtown law office. And at any Sunday afternoon cocktail party on Harlem's Sugar Hill there are almost sure to be porters and chauffeurs and elevator operators. Once away from their menial jobs there are many, such youngsters who can don Phi Beta Kappa keys and talk about Menckens.

You'd think a Harvard graduate and former college professor ought to be able to live in some degree of affluence. Yet Augustus Granville Dill is obliged to combine a lot of enterprises to get along. He has, for one thing, a book shop; yet he sells so few books that most of the space in his little store is occupied by a concert grand piano. He exhibits paintings and etchings done by other Negroes, and once in a blue moon collects a small commission on a sale. An accomplished organist, he collects a fee each Sunday for playing in Dr. John Haynes Holmes' Community Church downtown. And yet most of his income is derived from taking telephone messages for people of the neighborhood who can't afford phones in their homes or shops.

Cultural Leader
In spite of his catch-as-catch-can existence, Dill is one of the foremost cultural, and therefore social leaders, of Harlem. He has discovered and aided dozens of talented artists and authors and is monthly presents the latter in his store.

Subscription price for the whole series is 50 cents, and all the money goes to the performers. Dill himself is race-proud but personally modest. In conversation he may say, "When I left school in Massachusetts . . ." but never "When I graduated from Harvard in 1908 . . ."

The walls of the shop are literally covered with photos and tributes to the greatest Negro figures in arts and letters and education—James Weldon Johnson, Paul Laurence Dunbar, W. E. B. Dubois, Claude McKay, Langston Hughes, Roland Hayes, Jules Bledsoe, Harry T. Burleigh (composer of spirituals), W. C. Handy (C.S.



Louis Blues), Hall Johnson—and scores of others. Among the artists are H. O. Tanner, who is internationally known, Aaron Douglas, W. E. Scott, E. Simms Campbell (you've seen his stuff in national magazines), and Meta Fuller and Augusta Savage, sculptors.

"Dickty" and "Hinkty"
There is, however, a shallow stratum of "dickty" Negroes who live on "Strivers' Row" and have chauffeurs for their cars and servants for their homes. A few doctors and lawyers among them, but mostly real estate men, such as John Nail and Watt Terry, who are the richest people in Harlem since A'Leila Walker moved to Indianapolis. A'Leila inherited the hair-straightening fortune of her mother, Madame C. J. Walker.

Sugar Hill, on the western heights of Harlem, also has been a "hinkty" district since Jules Bledsoe led a migration there. And farther up on Seventh Avenue is another exclusive section—an entire square block occupied by the Paul Lawrence Dunbar apartments, a Rockefeller project. No "buffet flats" here, or bawdy rent parties either, but neat cubicles occupied by the intelligentsia and as yet unvisited by Carl Van Vechten. Bess Bruce, Fannie Hurst's secretary, is one of the residents, and her father-in-law, R. C. Bruce, one-time superintendent of several schools in Washington, manages the development.

Van Vechten, by the way, isn't around Harlem any more. The black belt was shocked by his "Nigger Heaven," not because of any essential inaccuracy, but rather because the figures in it were too thinly veiled by fiction.

Almost all white writers are looked upon with suspicion, with perhaps the sole exception of Julia Peterkin, author of "Bright Skin" and "Scarlet Sister Mary," the Pulitzer Prize winner of 1928. At least once a year Miss Peterkin comes North to pleasure herself in Harlem. And Harlem turns out to treat her as purty as it kin.

"The Oppermanns," by Lion Feuchtwanger, is probably the best of the many novels recently written to describe what Hitler's accession to power in Germany meant to the German Jews.

It indulges in no hysterical screaming and it is not simply a case history of atrocities. It recognizes the fact that revolutions are not kid-glove affairs, that pre-Hitler Germany was under an unendurable pressure, and that many Jews today go about the streets of Berlin unmolested.

But because of its very moderation, it puts all the more emphasis on the stupidity and the barbarism involved in the anti-Semitic program of the Nazis.

Feuchtwanger presents us with a typical upper-class Jewish family in Berlin, the Oppermanns. One Oppermann runs the family business, another is a writer, the third is a doctor of medicine. They are people of culture, German to the core and intensely proud of it.

The storm comes—and for all that they see it coming, it takes them by surprise. They cannot believe that mass prejudice and ignorance can gain the upper hand in 20th century Germany.

The business man does not realize it until his son is driven to suicide by a Nazi schoolmaster; the doctor doesn't until storm troopers drag him from the bedside of a patient; the writer doesn't until he is forced to flee to Switzerland for his life.

In the story of this family there is a better translation into human terms of the tragedy of present-day Germany than in any other book I have seen.

Published by Viking, the book sells at \$2.50.

The New Deal In Washington

WASHINGTON — Brain-trusters finally have met a problem which proved too tough for them. They think the new dairy control plan is the most vulnerable of the crop reduction programs. But they couldn't conjure up a better one. AAA submits the plan with fear, it not trembling. It asks milk and butter producers to say whether they want it or not. The previous milk plan and other dairy efforts collapsed.

After months of the most terrific brain-wrenching in New Deal history, participated in by all hands at AAA, out popped this one as a last resort.

Secretary Wallace and AAA Administrator Davis are cool toward it. Proponents have worked hard, thus far vainly, to get the approval of Consumers' Counsel Fred Howe. Chief backers of the plan within AAA are two minor administrators, Alfred D. Stedman and H. R. Tolley.

AAA jitters were revealed when, of the first two dairy industry representatives to assail the plan violently, one was barred from the Department of Agriculture and the other officially and publicly castigated.

American farmers get nearly 25 per cent of their income from milk—three times more than from wheat, so any national milk plan is important.

The plan would curb marketing of milk by 15 per cent. It involves benefit payments of \$155,000,000 to \$300,000,000 to farmers reducing sales, and process taxes of half a cent a quart on milk and five cents a pound on butter.

It would distribute some milk to underfed city children, kill diseased cows, and redistribute healthy cows to needy farmers.

Without the plan, AAA says, dairy farmers face new and more serious distress. But difficulties involving administration, farmer cooperation, and consumer reaction lie ahead.

About 6,000,000,000 pounds of milk are sold by farmers marketing their own. Farmers probably won't drink surplus milk and cow-killing adds to the meat control problem.

President Roosevelt seized that key from the tight-fisted liquor distillers who have held it since repeal, when he enlarged quotas on liquor imports. Although most liquor users prefer to patronize the legitimate industry, the bootlegger's wars still offer devastating competition and the prices on illicit stuff are attractive.—Madison Eagle.

"HOSS" TRADING AGAIN.
The character of "David Harum," as played by Will Rogers in current moving pictures, will see rather strange to the younger folks of today, who only see horses at the race track or in circus parades. And to the older people seeing it, may come the thought that the shrewdness that once characterized Uncle Sam's international dickering disappeared almost as completely as horse trading, for a time.

Unfortunately, our Uncle Sam has on several notable occasions fallen from grace in the eyes of the world since horse trading became one of the lost arts. Beginning with the rise of the automobile, we saw the United States getting into situations, notably war debts, from which much of the glory was on the other side. We soon were in the position of Harum when he paid top price for a balky horse.

There are indications today that Uncle Sam is regaining some of his old cunning. He may not be able to sell the "balky horse" of American war debts, but otherwise he is making trades in which the advantage is somewhat on his side and he has kept out of several like the London conference, in which he would have been sold a blind horse with the heaves if Europe could have had its way.

Strangely, too, Uncle Sam's comeback as a horse trader among nations parallels the comeback of the horse itself to the farm life of the nation. The tractor is giving place to the more economical horse all over the country, and the horse trader is reappearing in the land, although not on quite as elaborate a scale as in the days when David Harum was about—Miami Herald.

TAKING STATES OUT OF POLITICS
Judge Clark of the Federal Court of New Jersey, proposes a sweeping New Deal in State government. Its essence is the abolition of party politics and the substitution of manager for political government. The manager, or chief executive, would be chosen by a commission, or executive council, to be elected by districts into which the State would be divided.

The council would also pass on appointments. The legislature would have but one chamber. Voters must have at least a grammar school education, and citizens failing to vote on two succeeding elections would lose the right. Voting would be by proportional representation.

The Clark idea, down even to the requirement of proportional voting, is an application of the City Manager Idea to the State. But the State, unlike the city, has interests of legislative policy that are political in the true sense of the word. Social and tax legislation, for instance, must be based on definite policies as to which citizens have widely varying views. There would inevitably be parties in States, even if they did not bear national labels. Citizens are occasionally able on "off" years to separate State from national issues. But it is not the natural American way and it is hard to see how parties can function on a national scale—a thing every way desirable if the nation is to escape the bloc system—if they are not organized to function in the several states.—Philadelphia Bulletin.

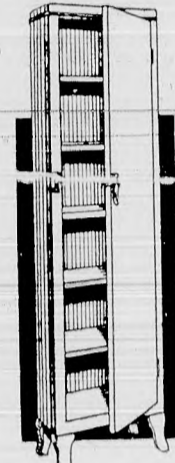

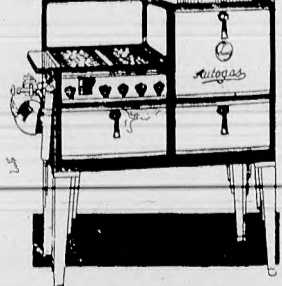

28 CHICKENPOX CASES REPORTED IN COUNTY

Leads List, Followed By Whooping Cough, Scarlet Fever

(By Staff Correspondent) FREEHOLD, April 6.—Chickenpox, scarlet fever and whooping cough were most conspicuous of seven classes of communicable diseases included in the report submitted by the county health officer to the state department yesterday for the week ending March 24 and March 31. The three classes contributed 57 cases out of a total of 66.

Chickenpox led the three and the entire list with a total of 28 cases scattered between Manasquan and Rumson. Whooping cough was next with 18 and scarlet fever next with 11. There were three cases of mumps, three of tuberculosis, two measles and one pneumonia.

Fair Haven was in the van on the chickenpox tally with a total of 14 cases. Long Branch had five, Manasquan four, Red Bank two, and Asbury Park, Neptune and Rumson each one.

Asbury Park took the honors on the whooping cough list with a report of 12 cases. Long Branch had three, Freehold Borough two and Allenhurst one. The scarlet fever cases were divided among 10 communities. Long Branch reported two and the following places each one: Bradley Beach, Manasquan, Matawan, Middletown Township, Millstone Township, State Hospital, Marlboro, Red Bank, Spring Lake, and Wall Township.

The three mumps cases were reported one each at Asbury Park, Long Branch and Middletown Township; the three tuberculosis cases were reported one each at Atlantic Highlands, Keyport and West Long Branch; the two measles cases by Allentown and Fair Haven and the single pneumonia case by Long Branch.

CLIFTON DYE WORKS FINED \$1,000 FOR NRA CODE RULES VIOLATION

TRENTON, April 6.—(AP)—The Allied Dye and Print Works, Inc., of Clifton, was fined \$1,000 in Federal Court today in one of the first criminal prosecutions in the country for violation of NRA codes. The company pleaded guilty.

CONSTABLE SLAIN. POLICEMAN KIDNAPED

Chief Abducted By 2 Outlaws, Woman After Officer Is Murdered

MIAMI, Okla., April 6.—(AP)—Constable Cal Campbell was slain and Chief of Police Percy Boyd of Commerce, near here, was kidnaped today by two outlaws and their blond woman companion.

Boyd and Campbell had tried to investigate a bullet hole in the windshield of the car in which the two men and the woman had become stuck in a mudhole. Witnesses said that before the two reached the machine the occupants opened fire and Campbell fell, dying almost instantly.

The police chief was taken in the car and it sped northwestward toward Chetopa, Kas., about 10 miles from Commerce. It was not known whether Boyd was wounded. Officers said they were not yet certain whether the shooting was done with a machine gun.

They were investigating to determine if Bonnie Parker, the cigar-puffing girl friend of Clyde Barrow, desperado, is a blond and if perhaps the men were Barrow and Raymond Hamilton, who escaped, aided supposedly by Barrow, from a Texas prison farm some time ago.

McC Campbell Flays N. J. Government

(Continued from First Page) breath expressed a desire to reorganize the schools of today. "The school I would like to attend would last but 2 or 3 hours a day," the speaker said, "and would have the facilities to do things." He had reference to chemistry and machinery. He declared the students of today "are not taught enough to do things" and that colleges are turning out thousands of young men and young women unable to make their way.

Assemblyman McC Campbell dropped the subject of education for a minute to discuss the national problems pointing to the present "revolution as the greatest in the history of the world.

Conditions "Appalling" Turning his attention to his home state and its management, he said: "There is no state in the English-speaking world where the government is so corrupt, so inefficient as in the state of New Jersey."

Termining conditions appalling, Assemblyman McC Campbell said the government is hamstrung by ancient political systems that are leading it into worse chaos. He declared the government can not survive unless its men are educated and then come back to his first subject to announce that he was "an enemy of the system by which they try to educate today."

He referred principally to the financial issue, declaring that home-owners are being pauperized and saddled with a heavy public debt. There are two alternatives, he said. "We must either repudiate the public debt or confiscate all property."

"The only thing to save the schools and keep them open is a new government. There is not enough money to run the government. We cannot go on."

It was then that McC Campbell announced that he doesn't expect to become the next Governor, confidentially, but "if it does there will be a new Constitution in three months."

Referring once again to world problems, the assemblyman said that prosperity can not be expected in the immediate future. He attacked the tariff as an obstacle to recovery and declared internationalism is the only solution to world troubles.

(Continued from First Page) concerning an alleged conversation between several persons known to have had a part in the alleged frame-up.

It was learned today that several witnesses in the case have been followed during the past few days by persons intent on molesting them. Extra precautions were being taken by Assistant Prosecutor Carlton today to see that no one tampered with the witnesses. Court officers as well as county detectives were keeping close watch over the group of witnesses to prevent any outsider from speaking to them.

Carlton has made it clear throughout the entire investigation that "certain individuals" had molested and even threatened many persons that he had questioned in the case. It was also reliably learned that the county detectives had been trailed by unknown persons while investigating several angles in the case which tended to bear out that the dope case was a conspiracy directed at Councilman Dr. Max Silverstein through his colored chauffeur.

Members of the household of Councilman Dr. Max Silverstein, employer of Leonard Johnson, colored, in the case, found it necessary to call police headquarters late Wednesday night when two suspicious characters were seen prowling around the premises.

Mrs. Silverstein yesterday refused to comment on the incident but it was learned from reliable sources that the house is now being guarded. Tonight is expected to see the climax of what is rapidly becoming known as a notorious conspiracy aimed at Dr. Silverstein by political enemies. The county physician has been a long-time worker in the new city government since his inception here, finding himself continually at odds with his four fellow members of council, who were indicted last week by the grand jury charged with violation of the State Election Laws.

Silverstein has made no secret of the fact that the whip of dictation has been heavily applied to members of council by outside interests. The physician has named publicly on several occasions Wayne D. Murray as being one of the so-called dictators of the policies pursued by his colleagues.

The medico-councilman has also quoted McMurray as saying: "If you don't go along with us, you'll get no support from the Asbury Park Press."

Although threatened with excommunication by McMurray's newspaper, Silverstein has fought a lone fight against overwhelming odds due to constant opposition by his four fellow members of the governing board.

The dope case which is expected to reach its conclusion before the year is up today has held the interest of persons all over the state as well as in the Metropolitan city. A climax of the case was the arrest of City Clerk Roland H. Loog by county detectives after it was alleged that he was on the verge of fleeing the country. Loog was later placed under \$5,000 bail which was furnished by his aunt, Dr. Ella Upham, and I was held as a material witness.

Another unusual feature of the case thus far was the arrest of Harold Canning, an employe of the Press, who is held in \$10,000 bail, also as a material witness. The arrest of Canning brought forth vituperative editorials directed at Assistant Prosecutor Carlton in the Asbury Park Press. William J. Couze, local banker, who supplied bail for Canning, also criticized the assistant prosecutor for rousing innocent people from their "slumbers" to supply bail. It was pointed out, however, that Canning after calling several persons connected with the Press to supply bail for him, was responsible for bringing Couze out of his slumbers to post the bond.

Reports, which could not be verified, indicated that Couze also supplied the bail for Martin "Mickey" Stein, West Side saloon proprietor, and Mrs. Marie Saunders, colored, proprietor, along with her husband, of the Ridge Avenue Inn, a Spokewood Avenue resort. These two people are held under \$2,500 bail each.

Stein and the Saunders woman are represented by Isadore J. Friedman, local attorney, and associate of Dr. Joseph H. Bryan in the now almost defunct Citizens and Taxpayers Association.

Although the mayor said he regarded the threatening letter he received the work of a crank, officers set a trap for the extortionist, but it failed when the writer did not appear.

The letter to the mayor said: "If you value your life, follow these instructions. 'At 9 o'clock Friday morning drop \$15,000 in a brown package out of a yellow taxi at 1396 E. 60th Street if you don't come clean look out.'"

The letter was signed "X" and a postscript added: "Remember, 1396 E. 60th Street."

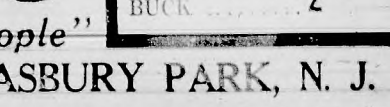

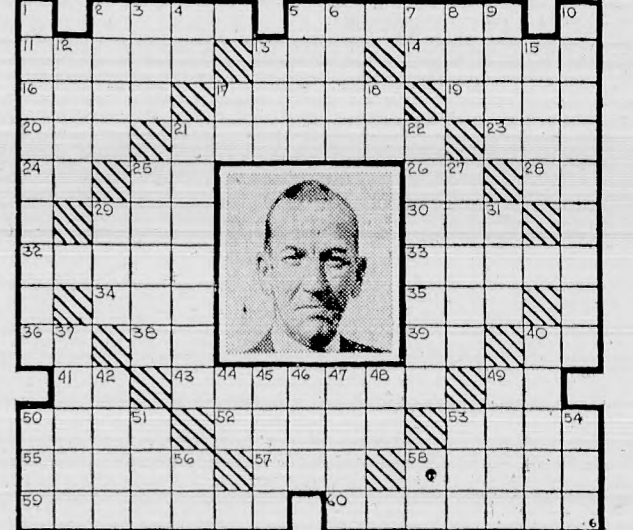
