ORDINANCE

An Ordinance Amending the "Code of Ordinances for the City of Lowell, Massachusetts", (the "Code") With Respect to Chapter 266 Entitled, "Vehicles and Traffic", by amending section 43 entitled, "Special Speed Regulations".

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOWELL, as follows:

"The Code of Ordinances City of Lowell, Massachusetts" hereinafter called the "Code", adopted by the City Council on December 23, 2008, is hereby amended with respect to Chapter 266-43, entitled "Special Speed Regulations", by adding the following new section "F":

§ 266-43 **Special speed regulations.**

F. In accordance with the provisions of MGL C. 90, §17, special school zone speed regulations of twenty (20) miles per hour have been established on the following streets:

Name of Street	Location
Adams Street	Extending from a point 210 feet to the north of Cross Street for 370 feet
Beacon Street	Extending from Whitney Avenue to a point 1,100 feet to the south of Whitney Avenue
Boylston Street	Extending from a point 360 feet to the south of Berwick Street for 560 feet
Bridge Street	Between Eustis Avenue and 13th Street
Broadway Street	Between Mount Vernon Street and School Street
Broadway Street	Between Worthen Street and Dummer Street
Chelmsford Street	Between Short Street and Liberty Street
Douglas Road	Extending from Glenellyn Road to a point 580 feet to the south of Glenellyn Road
East Merrimack Street	Between High Street and James Court

Ennell Street	Extending from Victor Street to a point 200 feet to the north of Victor Street.
Gorham Street	Between Manchester Street and Fay Street
Highland Street	Between Thorndike Avenue and South Street
Mammoth Road	Between Woodward Avenue and Columbia Road
Pine Street	Between Wilder Street and Morey Street
Rogers Street	Extending from High Street to a point 500 feet to the east of High Street
Stevens Street	Between Parker Street and Gallighan Road
Sycamore Street	Extending from Wentworth Avenue to a point 215 feet to the west of Wentworth Avenue
Wentworth Avenue	Between Birch Street and Sycamore Street
West Meadow Road	Extending from Gumpus Road to a point 950 feet to the south of Gumpus Road
Wilder Street	Extending from Pine Street to a point 525 feet to the south of Pine Street
Wilder Street	Between Avery Street and Midland Street

All provisions of the Code of the City of Lowell, as amended, which are consistent with this Ordinance, shall continue in effect, but all provisions of said Code inconsistent herewith, are repealed.

This Ordinance shall take effect upon its passage in accordance with the provisions of Chapter 43 of Massachusetts General Laws.
