ORDINANCE NO. 2022-06**

**AMENDING CHAPTER 394 “WATER” OF THE CITY CODE BY AND SETTING THE  
SCHEDULE OR RATES**

WHEREAS, the 2022 PennVEST note of the City of Lock Haven will be secured by a lien on its water revenues; and

WHEREAS, PennVEST requires the enactment of an ordinance prior to settlement providing that the City of Lock Haven has provided for the implementation of sufficient rates within three months of the scheduled amortization date as defined at settlement (by January 31, 2024), where such rates shall cover all operational and maintenance costs, the debt service on the PennVEST water construction loan, and the debt service on all other outstanding debt of the funding recipient;

NOW, THEREFORE, BE IT ORDAINED that if the cost-sharing agreement with the Central Clinton County Water Filtration Authority and the Suburban Water Authority and the city does not contribute the revenue needed to meet the obligations of the city to PennVEST, the City Council of Lock Haven does intend to increase water user rates subject to a successful application to the Pennsylvania Public Utility Commission as follows no later than January 31, 2024 and that the city will take the necessary steps to apply to the Pennsylvania PUC to increase those rate to the level needed to meet the city’s obligation in the PennVEST borrowing:

**§ 394-15 Schedule of rates.**

The quarterly charges for the supply of water by the City of Lock Haven to customers within the City of Lock Haven be and hereby are fixed and established based on the schedules below.

**A. Minimum charges.**

- (1) Residential customers. Minimum charges per quarter shall be based on the size of the meter. Consumption allowance for the minimum charge is 2,000 gallons per quarter.
