## Local Law No. 5 of 2024

A Local Law amending Chapter 147 of the Manorhaven Village Code to add "No Parking"

**BE IT ENACTED**, by the Board of Trustees of the Incorporated Village of Manorhaven, as follows:

#### New Language

#### [Old Language]

Section 1. Chapter 147, entitled "Vehicles and Traffic" of the Village Code is hereby amended as follows:

§ 147-46 Schedule X: No Parking Anytime.

In accordance with the provisions of § 147-17, no person shall park a vehicle at any time upon the following streets or parts of streets:

Cottonwood Road on East Side located from Manorhaven Boulevard to a point 30 Feet north thereof.

Section 2. This local law shall take effect immediately upon filing with the Office of the Secretary of State.

### Section 3. Authority.

The Board of Trustees of the Village of Manorhaven is authorized to adopt this local law pursuant to Village Law 7-722, as well as Municipal Home Rule Law 10(1)(i), 10(1)(a)(1) and 10(1)(a)(2).

### Section 4. Severability.

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

#### Section 5. Effective Date.
