**AN ORDINANCE OF THE TOWNSHIP OF MANTUA  
AMENDING CHAPTER 143 “VEHICLES AND TRAFFIC”  
ARTICLE XIII, SCHEDULES, §143-33 SCHEDULE II: PARKING PROHIBITED AT  
DURING CERTAIN HOURS OF THE CODE OF THE TOWNSHIP OF MANTUA**

**WHEREAS**, the following amendment to Chapter 143 of the Code of the Township of Mantua have been recommended by the Chief of the Police as requested by the Mantua Township School District to the Township Committee of the Township of Mantua to amend the Code; and

**WHEREAS**, in all other respects Chapter 143 of the Code of the Township of Mantua shall remain in full force and effect.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Mantua, County of Gloucester, and the State of New Jersey, that Chapter 143, Vehicles and Traffic, Article 143-33, of the Code of the Township of Mantua is hereby amended as follows:

**AMEND §143-33 to read as follows:**

**§143-33. Schedule II: Parking Prohibited During Certain Hours.**

<b>Street</b>	<b>Side</b>	<b>Hours/Days</b>	<b>Location</b>
<u>Spruce Street</u>	<u>South</u>	<u>All school days during school hours</u>	<u>From a distance beginning 25 feet from Mantua Blvd. (CR 676) to a distance 112 feet from Mantua Blvd. (CR 676)</u>


**THIS ORDINANCE** shall take effect immediately upon final passage and publication as required by law.
