Village of Manlius

Local Law No. 1 of the year 2024.

A local law amending the Village of Manlius Code sections 17-2 and 17-3 regarding the Parks and Recreation Board.

Be it enacted by the Board of Trustees of the

Village of Manlius as follows:

Section 1. Legislative Purpose. The amendment provides that the Mayor shall appoint a member of the Village Board of Trustees to serve as a liaison to the Parks and Recreation Board, rather than the appointed trustee serving as a member of and chairman of the Parks and Recreation Board as the current Code provides.

Section 2. Sections 17-2 and 17-3 of the Village of Manlius Code currently provide as follows:

**§ 17-2. Appointment of Chairman; term.**

One Village Trustee shall be appointed by the Mayor to be a member of the Parks and Recreation Board and serve as its Chairman for a term of one year, commencing on the first Monday in April of each year.

**§ 17-3. Appointment of Board members; terms.**

The Mayor shall appoint, with the approval of the Village Board, six members to the Parks and Recreation Board, in addition to the Chairman. Terms of office shall be for two years commencing the first Monday in April of each year.

**§ 17-2. Appointment of Liaison; term.**

One Village Trustee shall be appointed by the Mayor to be a liaison to the Parks and Recreation Board for a term of one year, commencing on the first Monday in April of each year.

**§ 17-3. Appointment of Board members and election of Chair; terms.**

The Mayor shall appoint, with the approval of the Village Board, seven members to the Parks and Recreation Board. Terms of office shall be for two years commencing the first Monday in April of each year. The Board shall annually elect a Chair from its own members to serve for a term of one year commencing on the first Monday in April of each year.

Section 3: This Local Law is effective upon filing with the Secretary of State.

I hereby certify that the local law set forth above or annexed hereto, designated as local law No. 1\_\_ of 2024 of the Village of Manlius was duly passed by the Village Board of Trustees of the Village of Manlius on the 12th of March, 2024, in accordance with applicable provisions of law.

I further certify that I have compared the preceding local law with the original on file in this office and that the same is a correct transcript therefrom and of the whole of such original local law, and was finally adopted in the manner indicated above.


