A local law amending the Village of Manlius Code sections 99-11.2, 99-14, and 99-15 regarding drive-through uses.

Section 1. Legislative Purpose. The amendment provides that there may be no more than one restaurant drive-through use per district in a Planned Unit Development district, and no more than one drive-through use per parcel in a Commercial or Commercial-1 district.

Section 2. Pursuant to section 99-35 of the Village of Manlius Zoning Code, the Village Board hereby amends sections 99-11.2, 99-14 and 99-15 of the Zoning Code as follows:

- The current section 99-11.2(B)(3) is amended by adding the following language at the end of that section: "There shall be no more than one restaurant drive-through use permitted in any single PUD District."
- The current section 99-14(C) is amended by adding the following language at the end of that section: "There shall be no more than one drive-through use permitted on any single parcel in a Commercial 1 District."
- The current section 99-15(I) is amended by adding the following language at the end of that section: "There shall be no more than one drive-through use permitted on any single parcel in a Commercial District."

Section 3: This Local Law is effective upon filing with the Secretary of State.
