

ORDINANCE NUMBER 01-17

TOWN OF MANITOWISH WATERS,
VILAS COUNTY, WISCONSIN

AN ORDINANCE APPROVING AND ADOPTING THE
TOWN OF MANITOWISH WATERS COMPREHENSIVE PLAN

WHEREAS pursuant to the provisions of Section 66.23(2) and (3) of the Wisconsin Statutes, the Town of Manitowish Waters is authorized to prepare and adopt a Comprehensive Plan for the town's vision of the future growth and development of the community as defined in Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes; and

WHEREAS the Town Board of the Town of Manitowish Waters, Wisconsin, has previously adopted written procedures designed to foster public participation in every stage of the preparation of the comprehensive plan as required by Section 66.1001(4)(a) of the Wisconsin Statutes; and

WHEREAS the Town of Manitowish Waters, through its Plan Commission and through community participation, with the assistance of Martenson and Eisele, Inc., has prepared, developed and drafted a "Recommended" Comprehensive Plan for the Town of Manitowish Waters; and

WHEREAS the Town of Manitowish Waters Plan Commission has, by majority vote of the entire Plan Commission, as recorded in its official minutes, adopted a resolution recommending to the Town Board the adoption of the document entitled "Town of Manitowish Waters Comprehensive Plan", a copy of which document is on file in the Office of the Town Clerk and has been placed at the City of Manitowish Waters library for public inspection, containing all of the elements required under the provisions of Section 66.1001(2) of the Wisconsin Statutes; and

WHEREAS the Town Board has previously held a public hearing to solicit further input on the proposed Town of Manitowish Waters Comprehensive Plan 2013-2033 as required under the provisions of Section 66.1001(4)(d) of the Wisconsin Statutes;

NOW, THEREFORE, THE TOWN BOARD OF THE TOWN OF MANITOWISH WATERS, WISCONSIN, DOES ORDAIN AS FOLLOWS:

SECTION 1: That the "Town of Manitowish Waters Comprehensive Plan" be, and the same hereby is, authorized, adopted and approved as the Comprehensive Plan of the Town of Manitowish Waters, Wisconsin, pursuant to the provisions of Section 66.1001(4)(c) of the Wisconsin Statutes and shall serve as the Comprehensive Plan of the Town of Manitowish Waters, Wisconsin, from the effective date of this Ordinance.

SECTION 2: That a true, correct and complete copy of the Comprehensive Plan shall be maintained in the Office of the Town Clerk of the Town of Manitowish Waters and shall be available for public inspection during all regular business hours of that office.

SECTION 3: That the appropriate officers and officials of the Town of Manitowish Waters be, and the same hereby are, authorized to take all such other and further action as they shall deem necessary or appropriate under and pursuant to the provisions of Section 66.1001 of the Wisconsin Statutes to implement and carry out the terms and provisions of the Comprehensive Plan for the effective growth and development of the Town of Manitowish Waters as envisioned under and pursuant to the Comprehensive Plan.

SECTION 4: That all ordinances or parts of ordinances in conflict herewith be, and the same hereby are, repealed.

SECTION 5: That this ordinance shall take effect immediately upon the passage and publication of the same as made and provided by law.
