

**ORDINANCE NO. 2024-23**

**ORDINANCE APPROPRIATING \$240,197.38 FROM THE RESERVE FOR CAPITAL OUTLAY IN ORDER TO PROVIDE FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF MANTOLOKING, IN THE COUNTY OF OCEAN, NEW JERSEY.**

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF MANTOLOKING, IN THE COUNTY OF OCEAN, NEW JERSEY, AS FOLLOWS:

Section 1. \$240,197.38 from the Reserve for Capital Outlay is hereby appropriated by the Borough of Mantoloking, in the County of Ocean, New Jersey (the "Borough"), to provide for the following improvements or purposes:

Section 2. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law.
