**AN ORDINANCE AMENDING THE CITY OF MAROA CODE OF ORDINANCES,

WHEREAS § 163 of the City of Maroa Code of Ordinances is modeled after the Illinois Liquor Control Act (235 ILCS 5/); and,

WHEREAS it is necessary for the City to modify the Revised Code of Ordinances to remain consistent with State of Illinois statute; and,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:


SECTION 1. § 163-28 Gambling is hereby amended as follows:

It is unlawful to keep, place, maintain or operate any gambling device or instrument in and upon the premises used or occupied as a place where alcoholic liquor is sold or given away without possessing a valid gaming license from the City of Maroa, as regulated under the Revised Code of Ordinances § 105 Amusement Devices.




