## ORDINANCE O2024-14

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, AMENDING MANTECA MUNICIPAL CODE TITLE 10 VEHICLES AND TRAFFIC, CHAPTER 10.12 SPEED LIMITS, SECTION 10.12.020 DESIGNATED (SPEED LIMITS ON CERTAIN CITY STREETS)

WHEREAS, the California Vehicle Code (CVC) allows local authorities to increase or decrease the posted speed limits by ordinance to appropriate limits as determined by an Engineering and Traffic Survey for Speed Limits (Traffic Survey); and

WHEREAS, on May 2, 2023, the City of Manteca City Council (City Council) approved the current Engineering and Traffic Survey for Speed Limits and waived the first reading by substitution of title and introduced an Ordinance of the City Council of the City of Manteca, State of California, Amending Manteca Municipal Code Title 10 Vehicles and Traffic, Chapter 10.12 Speed Limits, Section 10.12.020 Designated (speed limits on certain city streets); and

WHEREAS, on May 16, 2023, City Council waived the second reading by substitution of title and adopted an Ordinance of the City Council of the City of Manteca, State of California, Amending Manteca Municipal Code Title 10 Vehicles and Traffic, Chapter 10.12 Speed Limits, Section 10.12.020 Designated (speed limits on certain city streets); and

WHEREAS, following ordinance adoption, safety concerns were raised by members of the public to the Traffic Solutions Committee recommending re-evaluation the speed limit for the segment of Moffat Blvd. between Powers Avenue and Main Street due to its proximity to Manteca High School, transit center, uncontrolled crosswalks. Engineering collected Traffic Survey speed data to conclude that the speed limit for the segment of Moffat Blvd. from Powers Avenue to Main Street shall be reduced by five mph; and

WHEREAS, the Traffic Survey, as defined in Section 627 of the CVC, must consider the prevailing speeds, collision records, pedestrian and bicycle activity, and roadway traffic and roadside conditions not readily apparent to the driver; and

WHEREAS, Amendment No. 01 of the Traffic Survey dated June 4, 2024, is prepared based on the most current California Manual on Uniform Traffic Control Devices (MUTCD) 2014 Edition Revision 8 and CVC sections 22357, 22358.5, 22358.6, and 22358.7; and

WHEREAS, the speed limits in Amendment No. 01 of the Traffic Survey dated June 4, 2024, are established at the nearest 5 mph increment of the 85th-percentile

speed of free-flowing traffic. In matching existing conditions with the traffic safety needs of the community, engineering judgment reduced the posted speed limit by 5 mph due to specific factors such as road characteristics, the pace speed, roadside development and environment, pedestrian activity, and collision history; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meeting of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

THE CITY COUNCIL OF THE CITY OF MANTECA DOES ORDAIN AS FOLLOWS:

**SECTION 1:** <u>Amendment</u>, Manteca Municipal Code Section 10.12.020, Designated, is hereby amended to read as follows:

## Section 10.12.020 Designated.

It shall be prima facie unlawful to operate any vehicle at a speed in excess of that established as follows:

The City Council hereby declares that it would have passed each section, sub-section, subdivision, paragraph, sentence, clause or phrase of this Ordinance, irrespective of the fact that any one or more sections, sub-sections, subdivisions, paragraphs, sentences, clauses or phrases may be declared invalid or unconstitutional.

<u>SECTION 3:</u> <u>Effective Date</u>. This Ordinance shall become effective thirty (30) days following adoption.
