# AN ORDINANCE BY THE McLEAN COUNTY BOARD AMENDING CHAPTER 205 FEES, ARTICLE XI MISCELLANEOUS CODE FEES, IN THE McLEAN COUNTY CODE

WHEREAS, the McLean County Board has certain ordinances which promulgate certain rules and regulations pertaining to the regulation of Food Service fees; and
