

**AN ORDINANCE BY THE McLEAN COUNTY BOARD  
AMENDING CHAPTER 205 FEES, ARTICLE XI MISCELLANEOUS CODE FEES, IN  
THE McLEAN COUNTY CODE**

WHEREAS, the McLean County Board has certain ordinances which promulgate certain rules and regulations pertaining to the regulation of Sewage Disposal Systems, Water Wells and Geothermal Exchange Systems fees; and

WHEREAS, the Health Department and Board of Health have recommended modifications to the fees for those services; and

WHEREAS, the Health Committee at their September 5, 2024 meeting and the Executive Committee at their September 9, 2024 meeting has concurred with such recommendation, now, therefore

BE IT ORDAINED by the County Board of McLean County, now in regular session, that the aforesaid Chapter 205 Fees, Article XI Miscellaneous Code Fees, Sub-section 205-40 Sewage Disposal Systems, Water Wells and Geothermal Exchange Systems is hereby amended to read as follows:

§ 205-40 Chapter 310, Sewage Disposal Systems, Water Wells and Geothermal Exchange Systems. Sewage disposal system, water well and geothermal exchange system fees shall be as follows:
