

ORDINANCE 2022 -16

AN ORDINANCE AMENDING ORDINANCE 2003-3 AND THE TOWNSHIP CODE, CHAPTER 5, ADMINISTRATION, ARTICLE V, ENTITLED "OFFICERS, BOARDS AND COMMISSIONS", CHAPTER 5-31.2, ENTITLED: "ECONOMIC DEVELOPMENT ADVISORY COMMISSION".

WHEREAS, the Township Council, by adoption of Ordinance 1998-29, created the Economic Development Advisory Commission in Medford Code Section 5-31-.2; and

WHEREAS, the Township Council amended Ordinance 1998-29 by adoption of Ordinance 2003-3, and

WHEREAS, the Township Council desires to reorganize the terms of the membership of the Economic Development Advisory Commission (EDC) as authorized by Ordinance 2003-3.

NOW THEREFORE BE IT ORDAINED by the Township Council of the Township of Medford in the County of Burlington and State of New Jersey, that the Code of the Township of Medford be hereby amended as follows:

SECTION ONE: The first paragraph of Section One of Ordinance 2003-1 (Medford Code Chapter 5-31.2) is hereby repealed and replaced to read as follows:

"There shall be an Economic Development Advisory Commission, to consist of seven (7) voting members and two (2) ex-officio members, which ex-officio members shall be permitted to vote in the absence of any of the seven voting members and all shall serve without compensation for their services. All appointments shall be made by a majority vote of the Township Council. All of the voting members shall serve a term of one (1) year. The purpose of this Advisory Commission is to assist the Medford Township Council in the development and maintenance of a positive business environment in the community. All members must have an interest in the economic development of Medford Township and shall preferably have a background in business. The two (2) ex-officio members shall be the Township Manager and the Planning Administrator. The Economic Development Advisory Commission shall meet periodically and shall advise or consult with Council and the Manager on the state of the business environment in the Township and recommend measures to improve same. All regular and special meetings of the Commission shall be open to the public. One at large member representing the Medford School District, for a term of one (1) year.

SECTION TWO: All Ordinances and provisions thereof inconsistent with the provisions of this Ordinance shall be and are hereby repealed to the extent of such inconsistency

SECTION THREE: If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this ordinance shall be deemed valid and effective.

SECTION FOUR: This Ordinance shall take effect immediately upon final passage and publication according to law.
