AMENDING CHAPTER 140 OF THE

TOWNSHIP CODE ENTITLED

"VEHICLES AND TRAFFIC"

WHEREAS, the Medford Township Engineer has reviewed and evaluated Fairview Road and Woods Drive intersection, which contains a crosswalk for the Cranberry Pines School, and

WHEREAS, the Medford Township Engineer has recommended parking restrictions be enacted on Fairview Road and Woods Drive, and

WHEREAS, the Township Council of the Township of Medford believes that the recommendations will protect the public safety and welfare of Township residents and visitors to the Township.

BE IT ORDAINED, by the Township Council of the Township of Medford, County of Burlington and State of New Jersey, that §140- 18 is hereby amended as follows:

Section One: § 140- 18 entitled "Schedule I: Parking Prohibited at All Times" shall be amended to include the following:

Name of Street	Side	Location
Fairview Road	North	to a point 700 feet west
Fairview Road	South	To a point 300 feet west
Woods Drive	Both	Entire length

REPEALER, SEVERABILITY AND EFFECTIVE DATE

- A. Any and all Ordinances and provisions thereof inconsistent with the provisions of this Ordinance shall be and are hereby repealed to the extent of such inconsistency.
- B. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this ordinance shall be deemed valid and effective.
- C. This Ordinance shall take effect immediately upon final passage and publication according to law.

Recommendations for changes to Municipal Ordinance

In July of 2022, a proposal for parking regulations was forwarded to the Medford Twp. Engineer.

On December 16, 2022, I received correspondence back from Engineer Christopher Noll who reviewed the parking proposal and agreed to the recommendations.

Originally, the proposal was:

- 1. Woods Drive, in both directions along the entire length of the roadway.
- 2. Fairview Road
 - a. From the intersection of Woods Drive on the northbound side to a point 700 feet west.
 - b. From the intersection of Woods Drive on the southbound side to a point 300 feet west to the exit of Cranberry Pines School

After reassessing the parking issue on Woods Drive, due to a return of normal pick up and drop off procedures at Cranberry Pines School, I would be recommending:

- 1. Woods Drive, modification of the proposal for the entire length of Woods Drive to only post:
 - . Posting statutory regulation parking signs for:
 - i. distance from stops signs,
 - ii. crosswalks,
 - iii. and intersecting streets
 - b. Posting the "no parking on this side of street" or similar signs to prevent parking along the raised barrier/road divider on Woods Drive.
- 2. Fairview Road, the recommendation is the same as the proposed:
 - a. From the intersection of Woods Drive on the northbound side to a point 700 feet west.
 - b. From the intersection of Woods Drive on the southbound side to a point 300 feet west to the exit of Cranberry Pines School
