ORDINANCE 2023 - 18

**AN ORDINANCE TO AMEND THE ADMINISTRATIVE CODE OF MEDFORD CHAPTER 140 THEREOF, ENTITLED "VEHICLES AND TRAFFIC" TO AMEND THE REGULATIONS FOR ON-STREET PARKING FOR HANDICAPPED PERSONS**

**BE IT ORDAINED** by the Township Council of the Township of Medford, in the County of Burlington and State of New Jersey, as follows:

**SECTION ONE:** Chapter 140 of the Administrative Code of the Township of Medford, specifically Section 140.28.3 entitled "On-Street Parking for Handicapped Persons" is hereby amended to include:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>DESCRIPTION</u>
Cherry Street	East	Beginning at a point 38 feet north of Union Street and extending to a point 64 feet north thereof.
Filbert Street	East	Beginning at a point 66 feet north of Coates Street and extending to a point 92 feet north thereof.
South Main Street	West	Beginning at a point 90 feet south of Union Street and extending to a point 116 feet south thereof.

**SECTION TWO:** This Ordinance shall take effect immediately upon final passage and publication as provided by law.
