ORDINANCE NO. 2024-8

WHEREAS, on or about April 24, 2003, the then-Mercer County Board of Chosen Freeholders adopted Ordinance No. 2003 – 8, which restated, amended and adopted in its entirety the Mercer County, New Jersey Administrative Code ("Code"); and,

WHEREAS, pursuant to Section 2.01.02 of the Code, the Board of County Commissioners has the power to adopt ordinances as it deems appropriate and necessary; and,

WHEREAS, Chapter 3.15 of the Code, *Insurance Fund Commission*, sets forth the composition and number of members of the Mercer County Insurance Fund Commission, namely: County Administrator; County Director of Personnel; and County Risk Manager, as set forth in Code Section 3.15.020, *Membership*; and,

WHEREAS, to ensure a sufficient number of members are available to attend meetings so as to address the important business of the Insurance Fund Commission, as well as adding additional experience to said Commission, it is in the best interests of the County to amend the County's Administrative Code to add additional members, namely: Deputy County Administrator and County Purchasing Agent; now, therefore,

BE IT ORDAINED, by the Mercer County Board of Commissioners as follows:

1. Chapter 3.15, *Insurance Fund Commission*, of the Administrative Code of Mercer County, be and hereby is amended as follows (<u>underlined</u> language is new, [bracketed] language is to be redacted):

Section 3.15.020. Membership.

The Mercer County Insurance Commission shall consist of [3] 5 members as follows:

- A. County Administrator, or designee.
- B. Deputy County Administrator, or designee.
- C.[B] County Director of Personnel, or designee.
- D. County Purchasing Agent, or designee.
- **E.**[C] County Risk Manager, or designee.

- 2. The Clerk of the Board is hereby directed to comply with the publication of the Ordinance within the provisions of the law.
- 3. This Ordinance shall take effect upon final passage and publication in accordance with the law.
- 4. Upon adoption, certified copies of this Ordinance shall be forwarded to the Office of the County Executive and County Counsel.
