ON THE 15<sup>TH</sup> DAY OF DECEMBER, 2025.**

**ORDINANCE NO. 12-15-25  
ANNUAL TAX LEVY ORDINANCE**

An Ordinance levying taxes for all corporate purposes for the City of Mendota, Illinois for the fiscal year commencing on the first day of May, A.D., 2026 and ending on the 30<sup>th</sup> day of April A.D., 2027.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MENDOTA, COUNTY OF LASALLE, STATE OF ILLINOIS, AS FOLLOWS:

SECTION I. That the amount herein after set forth, or so much thereof as may be authorized by law, and the same are here by levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such needed purposes as: CORPORATION, G.O. BOND, ILLINOIS MUNICIPAL RETIREMENT FUND, FIRE PROTECTION, FIRE PENSION, POLICE PROTECTION, POLICE PENSION, AUDIT, GENERAL LIABILITY INSURANCE, STREET LIGHTING, PARKS, PLAYGROUND, EMERGENCY SERVICES DISASTER AGENCY (CIVIL DEFENSE), SOCIAL SECURITY, SCHOOL CROSSING GUARD, WORKER'S COMPENSATION AND AMBULANCE for fiscal year of the said CITY OF MENDOTA, LASALLE COUNTY, ILLINOIS commencing the first day of May, 2026 and ending the 30<sup>th</sup> day of April, 2027.

SECTION II. The amount levied for each object and/ or purpose is as follows:
