AN ORDINANCE AMENDING THE MERCED COUNTY TREASURER – TAX COLLECTOR FEE SCHEDULE

(Amends Ordinance No. 1984 and Merced County Code Chapter 5.56)

THE BOARD OF SUPERVISORS OF THE COUNTY OF MERCED, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

Section 1: Ordinance No. 1984 is hereby amended as follows:

5.56.10 Purpose. Pursuant to Title 5, Division 2, Part 1, Chapter 12.5 of the California Government Code, any county can fix and collect charges for its services, in whole or in part, for the cost thereof.

5.56.20 Fee for Service. The Fee for Service is based upon costs of tax collections as mandated by the State and upon the cost of providing services for the 2023/2024 fiscal year, and is applied to the following services:

If any section, subsection, sentence, clause, word, or phrase of this ordinance is held to be unconstitutional or otherwise invalid for any reason, such decision shall not affect the validity of the remainder of this ordinance. The Merced County Board of Supervisors hereby declare that they would have passed this ordinance, and each section, subsection, sentence, clause, word, or phrase thereof, irrespective of the fact that one or more sections, subsections, sentences, clauses, words, or phrases be declared invalid or unconstitutional.

SECTION 3: Enactment. This ordinance shall become effective and be in full force on and after thirty (30) days of its passage and adoption. Prior to the expiration of fifteen (15) days from the passage and adoption thereof shall be published in a newspaper of general circulation printed and published in the County of Merced, State of California, together with the names of the members of the Board of Supervisors voting for and against the same.
