Authorization to Amend City Code as it Pertains to Parking Regulations for Uninspected and Unregistered Vehices

WHEREAS, the Corporation Counsel is recommending that a failure to display inspection and registration stickers be added to the provisions regarding parking restrictions.

NOW THEREFORE BE IT <u>Resolved</u>, and be it <u>Ordained</u>, by the Common Council of the City of Middletown, New York, as follows:

<u>Section 1</u> – The Code of the City of Middletown, N.Y., Chapter 460, Vehicles and Traffic, is hereby amended by adding a new subsection (a) to Section 460-23.1, Parking restrictions on uninspected and other vehicles, to read as follows:

§ 460-23.1(a). Parking restrictions on vehicles which fail to display a valid inspection or registration sticker. The parking of any motor vehicle which does not properly display a valid

inspection or registration sticker in City-owned or -operated parking lots and on City streets is prohibited.

<u>Section 2</u> – The Code of the City of Middletown, N.Y., Chapter 460, Vehicles and Traffic, is hereby amended by replacing subsection (B) (1) (t) of Section 460-41, Penalties for offenses, to read as follows:

§460-41(B)(1)(t). Uninspected, unregistered, junk motor vehicles, and vehicles for sale in violation of Section 460-23.1: \$100.

<u>Section 3</u> – The Code of the City of Middletown, N.Y., Chapter 460, Vehicles and Traffic, is hereby amended by adding a new subsection (B) (1) (w) of Section 460-41, Penalties for offenses, to read as follows:

§460-41(B)(1)(w). Motor vehicles which do not properly display a valid inspection or registration sticker: \$50.

Section 4 - This resolution and ordinance shall take effect immediately.
