Ordinance Amending Chapter 7, Traffic, Section 7-15, Parking Prohibited During Certain Hours on Certain Streets, to Impose Parking Restrictions on the West Side of J.F. Kennedy Drive Between Violet Terrace and Nicholas Court

**BE IT ORDAINED** by the Borough Council of the Borough of Milltown as follows:

**SECTION 1.** Chapter 7, Traffic, Streets, Section 7-15, Parking Prohibited During Certain Hours on Certain Streets, is amended to add the following:

Name of Street	Sides	Hours/Days	Location
J.F. Kennedy Drive	West	7:30 a.m. to 8:30 a.m./ 2:30 p.m. to 3:30 p.m./ Monday through Friday From September 1 – June 30	From Violet Terrace to Nicholas Court

**SECTION 2.** All Ordinances or parts of Ordinance inconsistent with the provisions of this Ordinance shall be and the same are hereby repealed.

**SECTION 3.** If any paragraph, clause, provision, sentence, or application of this Ordinance is declared invalid for any reason whatsoever, the same shall not affect the validity or constitutionality of any other paragraph, clause, provision, sentence, or application of this Ordinance.

**SECTION 4.** This Ordinance shall take effect upon passage and publication as provided by law; and upon approval by the Commissioner of the Department of Transportation, if required.
