**Ordinance to Amend Chapter XXV, Water Section 25-4.1, Water Rates of the Revised
General Ordinances of the Borough of Milltown**

BE IT ORDAINED by the Borough of Milltown of the County of Middlesex and State of New Jersey that the Revised General Ordinances of the Borough of Milltown be amended as follows:

Section 1. Chapter 25, "Water," Section 4.1, "Water Rates," of the Revised General Ordinances of the Borough of Milltown is hereby amended as follows:

Section 25-4.1. Water Rates

a. The rates for water sold to users in the Borough of Milltown shall, for users of such water, be as follows:

Consumption Charges		
Quarterly		
Minimum Quarterly Amount	\$116.89	(0-7,500 Gallons)
Gallons Used in Quarter	Rate per thousand gallons	Amount of Gallons used
All Gallonage (If consumption exceeds 7,500 gallons)	\$10.98 per 1,000 Gallons	7,501-15,000 Gallons
	\$13.76 per 1,000 Gallons	15,001-22,500 Gallons
	\$16.54 per 1,000 Gallons	Over 22,500 Gallons

b. The rates shall take effect with the July 1, 2024 consumption.

* * * *

Section 2. Each clause, section or subsection of this Ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.

Section 3. All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed as to the extent of such inconsistency.

Section 4. This Ordinance shall take effect immediately upon adoption and publication according to law.
