ORDINANCE 24-1541**



**Ordinance to Amend Chapter XXVI, Sewer, Section 26-7.9 Sewer Use Charges of the Revised General Ordinances of the Borough of Milltown**

**BE IT ORDAINED** by the Borough of Milltown of the County of Middlesex and State of New Jersey that the Revised General Ordinances of the Borough of Milltown be amended as follows:

**Section 1.** Chapter 26, "Sewer," Section 26-7.9 "Sewer Use Charges," of the Revised General Ordinances of the Borough of Milltown is hereby amended as follows:

Section 26-7.9. Sewer Use Charges.

a. Consumption charges.

<u>Consumption Charges</u>

Minimum Quarterly Amount	\$199.33	(0-7,500 Gallons)
<b>Gallons Used in Quarter</b>	<b>Rate per thousand gallons</b>	<b>Amount of Gallons used</b>
All Gallonage (If consumption exceeds 7,500 gallons)	\$4.11 per 1,000 gallons	7,501-15,000 Gallons
	\$5.75 per 1,000 gallons	15,001-22,500 Gallons
	\$8.05 per 1,000 gallons	Over 22,500 Gallons

b. The rates shall take effect with the July 1, 2024 consumption.

**Section 2.** Each clause, section or subsection of this Ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the Ordinance shall not be affected.


**Section 3.** All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed as to the extent of such inconsistency.

**Section 4.** This Ordinance shall take effect immediately upon adoption and publication according to law.
