ORDINANCE NUMBER 1003-2026

ORDINANCE AMENDING CHAPTER 10, SECTION
10-13, ENTITLED “SEWERS & SEWAGE DISPOSAL”.

WHEREAS, the Chief Financial Officer of the Borough of Milford has conducted an analysis of Milford Borough’s Sewer Department’s Customers, Revenues, Rates, and Fees, and has determined that the existing fees and connection charges require updating; and

WHEREAS, the revised fees and connection charges as hereby modified as follows:

SECTION I.

Amendments to Chapter 10, Section 10-13.

Section 10-13 Sewers & Sewage Disposal

- A. Chapter 156, Article I, Sanitary Sewerage System. (§ 156-2)
 - (1) Connection fee: \$5,500.
 - (2) Quarterly sewer charge for calendar year 2026 and thereafter, until revised by Ordinance: \$128.00 per sewerage unit.
- B. Chapter 156, Article II, Individual Subsurface Systems. (§ 156-14B)
 - (1) For the issuance of any permit, certification or license: \$25.
 - (2) For a hearing: \$150.
- C. Chapter 156, Article III, Delinquent Water and Sewer Accounts. (§ 156-17)
 - (1) Late fee: \$25.

SECTION II.

Repealer.

All ordinances or parts of ordinances in conflict or inconsistent with any part of this Ordinance are hereby repealed to the extent that they are in conflict or inconsistent.

SECTION III.

Severability.

If any section, provision, or part of provision of this Ordinance shall be held to be unenforceable or invalid by any court, such holding shall not affect the validity of this Ordinance, or any part thereof, other than the part so held unenforceable or invalid.

SECTION IV.
Effective Date.

This Ordinance shall take effect after passage and publication in the manner provided by law.

PLEASE TAKE NOTICE that the foregoing Ordinance was introduced and passed on first reading on the 2nd day of March, 2026, at a meeting of the Borough Council of the Borough of Milford and will be taken up for final consideration and passage at a regularly scheduled meeting of the Mayor and Borough Council of the Borough of Milford to be held on the 16th day of March, 2026, at 7:00PM, or as soon thereafter as the matter may be reached, to be held at the Milford Borough Fire Company, located at 21 Water Street, Milford, New Jersey 08848.
