

ORDINANCE NO. 2024-368

**AN ORDINANCE OF THE BOROUGH OF MIDDLEBURG, SNYDER COUNTY, PENNSYLVANIA, AMENDING CHAPTER FIFTEEN, PART TWO HUNDRED AND ONE (§ 15-201) OF THE MIDDLEBURG BOROUGH CODE TO AMEND MAXIMUM SPEED LIMITS ON SOUTH CHARLES AVENUE AND EDMOND AVENUE AND CHURCH STREET.**

**WHEREAS**, the Council of the Borough of Middleburg, pursuant to its authority under the Pennsylvania Borough Code, amends Chapter Fifteen, Part Two Hundred and One (§ 15-201), “Maximum Speed Limits Established on Certain Streets” to establish maximum speed limits on specific streets within the Borough of Middleburg to promote the health, safety and welfare of the residents; and

**WHEREAS**, according to Chapter Fifteen, Part Two Hundred and One, the maximum speed limit for Church Street, Edmond Avenue and South Charles Avenue<sup>1</sup> is fifteen (15) miles per hour; and

**WHEREAS**, the Council of the Borough of Middleburg has proposed amending Chapter Fifteen, Part Two Hundred and One, to increase the maximum speed limit on Church Street, Edmond Avenue and South Charles Avenue from fifteen (15) miles per hour to twenty-five (25) miles per hour; and

**WHEREAS**, the Council of the Borough of Middleburg believes that this Ordinance will establish clear and specific requirements and prohibitions to protect the welfare of pedestrians and other persons seeking to use Edmond Avenue and South Charles Avenue.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED**, and it is hereby ordained and enacted by the Council of the Borough of Middleburg, Snyder County, Pennsylvania:

**Chapter 15, Part 2: Traffic Regulations, Chapter 15, Part 201. “Maximum Speed Limits Established on Certain Streets”** of the Code of the Borough of Middleburg are amended to include, as follows:

**§15-201. Maximum Speed Limits Established on Certain Streets.**

1. Maximum speed limits are established on portions of specified streets, as follows, and it shall be unlawful for any person to drive a vehicle on any

part of a street where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

2. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$35. Any person exceeding the maximum speed limit by more than five miles per hour shall pay an additional fine of \$2 per mile for each mile in excess of five miles per hour over the maximum speed limit.

DULY ENACTED AND ORDAINED this 10th day of September 2024, by the Council of the Borough of Middleburg, Snyder County, Pennsylvania, in lawful session duly assembled, after receiving public comment thereon and following proper notice of its intent to consider adoption of this Ordinance.




