#### Ordinance No. 31-2024

# AN ORDINANCE AMENDING CITY CODE CHAPTER 11 ("BUREAU OF PERMITS AND INSPECTIONS"), SECTION 75 ("CONSTRUCTION PERMIT FEES")

WHEREAS, existing Code Section 11-75 ("Construction Permit Fees") is unclear as to the cost of fixtures or receptacles or switches; and

WHEREAS, the Board of Commissioners finds that it is necessary to clarify said section to ensure the city is in compliance with the Department of Community Affairs requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MILLVILLE that Code Section 11-75 ("Construction Permit Fees") is hereby amended as follows:

#### Section One

§11-75. Procedure to secure structure.

- G. Electrical subcode fees. The electrical subcode fees shall be computed as follows:
  - (1). Fixtures and devices (items one to 50): \$75.
  - (a). Each additional outlet: \$25.00 Block up to 25 items is \$25.00 additional. (This includes fixtures, receptacles, switches, detectors, light poles, motors of less than one horsepower, emergency and exit lights, communication points, alarm devices, fire alarm control panels and thermostats.)

#### Section Two

Should any provisions of this ordinance be deemed invalid for any reason that invalidity shall not affect the remaining provisions of the ordinance, and the provisions and sections of the ordinance are hereby declared to be severable with respect to their validity.

### Section Three

This ordinance shall take effect twenty (20) days after final passage, according to law.
