AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE BOROUGH OF MILLERSVILLE TO REVISE RESIDENTIAL PARKING PERMIT REGULATIONS.

BE AND IT IS HEREBY ORDAINED AND ENACTED by Borough Council of the Borough of Millersville, Lancaster County, Pennsylvania, as follows:

Section 1. The Code of Ordinances of the Borough of Millersville, Chapter 350, Vehicles and Traffic, §350-41, Residential Parking Program Locations, Subsection D, Designation of residential permit parking areas and limitations, Paragraph (1), shall be amended by deleting the following residential permit parking regulation:

Street	Side	Between	<u>Limitation</u>
North Prince Street	East	West Charlotte Street and West Frederick Street	By permit only, except where "no parking at any time" signs are posted

Section 2. The Code of Ordinances of the Borough of Millersville, Chapter 350, Vehicles and Traffic, §350-41, Residential Parking Program Locations, Subsection D, Designation of residential permit parking areas and limitations, Paragraph (1), shall be amended by inserting the following residential permit parking regulations in alphabetical order:

Street	Side	<u>Between</u>	<u>Limitation</u>
North Prince Street	East	West Frederick Street and a point 640 feet south of West Cottage Avenue	By permit only, except where "no parking at any time" signs are posted
North Prince Street	East	West Cottage Avenue and West Charlotte Street	By permit only, except where "no parking at any time" signs are posted

Section 3. All other sections, parts and provisions of the Code of Ordinances of the Borough of Millersville shall remain in full force and effect as previously enacted and amended.

Section 4. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such

invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of Borough Council that the remainder of the Ordinance shall be and shall remain in full force and effect.
