## AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE TO AMEND CHAPTER 267 OF THE CODE OF THE TOWNSHIP OF MONROE, ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Township Council of the Township of Monroe has recommended certain amendments to Chapter 267 of the Code of the Township of Monroe and has determined that it is in the best interest of the Township to amend this specific section.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Monroe that the Code of the Township of Monroe is hereby amended to include the amendments herein.

**SECTION I.** Chapter 267, entitled "Vehicles and Traffic" is hereby amended as follows:

§ 267-48Schedule XV: Parking Prohibited at All Times.

In accordance with the provisions of § 267-19, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

**SECTION IV.** This Ordinance shall take effect twenty (20) days after final passage and publication as required by law.
