**AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS,  
STATE OF NEW JERSEY, AMENDING CHAPTER 81, "RECREATION",  
SPECIFICALLY ARTICLE II "FEES FOR RECREATION DEPARTMENT  
PROGRAMS" ESTABLISHING RECREATION FEES FOR VARIOUS TOWNSHIP-  
SPONSORED RECREATIONAL ACTIVITIES**

**WHEREAS**, Chapter 81-5, establishes a fee schedule for various Recreation Department Programs; and

**WHEREAS**, the fee schedule has not been revised since 2018; and

**WHEREAS**, the Mayor and Council wish to amend Chapter 81, Article II, Section 5 to establish new recreation fees.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Mount Olive, County of Morris, and State of New Jersey, as follows:

**SECTION 1.** Section 81-5, Fee Schedule, is hereby amended to establish a new Program/Activity and replaced with the following schedule:


Recreation Fees for 2024		
PROGRAM/ACTIVITY	FEE	Includes programs (for all ages):
Administrative Fees	\$5 - \$5000	Refund processing, field /facility permits, etc.
Arts/Crafts/Hobbies	\$0 - \$500	Art, Crafts, Cooking, Photography, Sewing, Jewelry, Interior Design, etc.
Beach	\$0 - \$1000	Admission, boating and classes, swim lessons, beach events, parties, etc.
Summer Programs	\$50 - \$1000	Day Camps, Trip camp, Sports camps, Fitness camp, Speciality summer programs
Certifications	\$0 - \$500	Red Cross Classes, Certified Pool Operator, Coaches trainings, etc.
Donations/Contributions	\$1 - \$1, 000,000	Sunshine Scholarship Fund, Sponsor signs/banners, Association Services, Fundraisers, etc
Enrichment	\$0 - \$1000	Music, Special Needs, Science, Engineering, Languages, Computers/Technology, Self Improvement, SAT-ACT Prep, Pre-School Programs, Nutrition, Online courses, etc.
Health/Wellness/Fitness	\$0 - \$200	Dance, Gymnastics, Exercise, Yoga, Karate, Mommy & Me Movement, Letting Go of Anger, Positive Parent, etc.
Special Events	\$0 - \$100,000	Event admission, parking, vendor spots, ride tickets/wristbands, Event Sponsorship, Tournament related services, event specific services/supplies, etc.
Sports	\$5 - \$1000	Badminton, Basketball, Volleyball, Cheerleading, Bowling, Ski/Snowboarding, Golf, Tennis, T-Ball, Sports Camps, Pickleball, etc.
Trips	\$5 - \$2000	Family Trips, Sports Games, Tours, Broadway, Concerts, Museums, Exhibits, etc.

**SECTION 2.** If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 3.** This Ordinance may be renumbered for purposes of codification.


**SECTION 4.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
