AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 63, PERSONNEL POLICIES, OF THE TOWNSHIP CODE TO REMOVE REFERENCES TO THE STATE HEALTH BENEFITS PROGRAM

WHEREAS, Article II of Chapter 63, Personnel Policies, of the Township of Mount Olive Code, governs nonparticipation of elected officials in the health benefits program; and

WHEREAS, there is a need to update Article II to remove references to the New Jersey State Health Benefits Program, as the Township no longer participates in the State program.

NOW, THEREFORE BE IT ORDAINED, by the Township Council of the Township of Mount Olive, County of Morris, State of New Jersey, as follows:

SECTION 1. Chapter 63, Personnel Policies, Article II, Nonparticipation of Elected Officials in Health Benefits Program, is hereby amended to read as follows:

§ 63-5. Acceptance of health benefits by elected officials.

No Township elected official shall accept health benefits under the Township's Health Benefit Program where there is a cost to the Township in providing such benefits. Nothing in this article is intended to preclude an elected official to obtain said health benefits where there is no cost to the Township and where the entire cost of said benefits is being borne by the elected official who chooses to obtain said benefits.

§ 63-6. Waiver of entitlement.

Each elected official shall execute the necessary form to waive his or her entitlement to health benefits except as set forth in § 63-5. No elected official shall receive any incentive, monetary or otherwise, made available as a result of the waiver of health benefits under the Health Benefits Program.


SECTION 2. Ordinances, resolutions, regulations or parts of ordinances, resolutions and regulations inconsistent herewith are hereby repealed to the extent of such inconsistencies.

SECTION 3. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portions of this Ordinance.

SECTION 4. This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.


