

**TOWNSHIP OF MONTVILLE
ORDINANCE NO. 2023-22
AMENDMENT TO ORDINANCE NO. 2022-05**

WHEREAS, the Township Committee establishes salaries and/or wages for all Township employees by ordinance; and

WHEREAS, Ordinance 2022-05 was adopted by the Township Committee on February 8, 2022 establishing such salaries and/or wages; and

WHEREAS, Ordinance 2022-05 must be amended in order to revise the Step 1 and corresponding Step 2 rates to be in compliance with the NJ minimum wage rates for the titles of Animal Attendant and Museum Attendant, and to add the title of R.E.H.S. 1 Trainee/Right to Know Coordinator

BE IT ORDAINED, by the Township Committee of the Township of Montville, in the County of Morris, and State of New Jersey, as follows:

Part 3 - Sections 2 through 4

The White Collar Salary and Wage Ordinance within the Township of Montville for those hired after January 1, 2022, shall be amended to reflect the revised rates for the following titles:


