## **ORDINANCE # 2024-11**

## AN ORDINANCE TO AMEND AND SUPPLEMENT § 132-11 OF THE GENERAL ORDINANCES OF THE TOWNSHIP OF MOUNT LAUREL UPDATING THE FEES FOR THE SOIL REMOVAL PERMIT

WHEREAS, the Township of Mount Laurel (the "Township") requires a permit to move any soil from, in or upon any land in the Township; and

WHEREAS, in accordance with § 132-11, the Township requires a fee for this permit; and

WHEREAS, the Township desires to update their fees for the soil removal permit to better reflect current economic considerations;

NOW, THEREFORE, BE IT ORDAINED, by the Township of Mount Laurel, County of Burlington, State of New Jersey, that the Code of the Township of Mount Laurel, be amended and supplemented as follow:

"§ 132-11 - Permit Fee

Together with the application there shall be deposited with the Township Clerk a permit fee computed at the rate of \$0.25 per cubic yard, multiplied by the estimated number of yards to be removed within the permit period, of soil as defined in this chapter; provided, however, in no event should said fee be less than \$250.00. However, the Township Council may waive or modify this requirement for the entire payment initially, but shall require not less than 10% of the total permit fee to be paid with the application, but in no event less than \$25. The balance of the fee shall be paid in monthly installments equal to the number of yards removed in each month multiplied by the amount stipulated in this section. The monthly installments shall be paid on or before the tenth day of the month. Failure to make payment on this date shall result in suspension of the permit until all arrears shall have been paid."
