#### LOCAL LAW NO. 3 OF 2024

A LOCAL LAW AMENDING LOCAL LAW NO. 5 OF 2022 WHICH ESTABLISHED A PROCEDURE TO CREATE AN AFFORDABLE, SUPPORTIVE AND VETERANS SUPPORTIVE HOUSING FLOATING ZONE

Be it enacted by the Town Board of the Town of Montgomery, County of Orange, State of New York as follows:

### Section 1. Title.

This Local Law shall be referred to as "A LOCAL LAW AMENDING LOCAL LAW NO. 5 OF 2022 WHICH ESTABLISHED A PROCEDURE TO CREATE AN AFFORDABLE, SUPPORTIVE AND VETERANS SUPPORTIVE HOUSING FLOATING ZONE".

## Section 2. Statement of Intent.

The Town Board has determined that it is necessary to amend Local Law No. 5 of 2022, in order to clarify that workforce and senior housing would be available categories in order to qualify for approval of a floating zone and that every eligible category for floating zone designation need not be included in a project if said project includes a substantial number of qualifying categories.

## Section 3. Amendments to Town Code

The Town of Montgomery Code Section 235-6.6 entitled "Affordable, Supportive and Veterans Supportive Housing Floating Zone is hereby amended as follows:

## A. Section 235-6.6 title and abbreviation changed.

- 1. Town Code Section 235-6.6 shall henceforth have the following section heading:
  - "The Senior, Affordable, Workforce, Supportive and Veterans Supportive Housing Floating Zone"
- 2. All references to the section title within the text of the section shall be deemed to be amended to the foregoing title and all abbreviations within the section shall be changed from "ASVS" to "SAWSVS".

## B. Section 235-6.6(A) amended.

Subsection 235-6.6(A) entitled: "Statement of Intent and Objectives" is hereby amended to add a subsection 3 as follows:

(3) It is not necessary that the proposed project for which a floating zone is sought include each category of targeted housing specified in Recommendation 21.8 of the Montgomery Comprehensive Plan. For example, a project may be landed as a floating zone under this section if housing is provided exclusively for the senior, workforce and veterans populations, or the project is specifically designed for the senior and special needs populations. The goal is to attract projects that address a substantial community need using some, but not necessarily all, of the identified housing categories.

### C. <u>Section 235-6.6(C)(5) amended</u>.

Subsection 235-6.6(C)(5) entitled: "Criteria for authorization of SAWSVS Floating Zone" is hereby amended to include the following bolded language:

(5) Proposed units must be funded and/or income-restricted under the supervision of a department of New York State, Orange County, or the Town of Montgomery for the purposes of providing dwellings with or without supportive services to households whose householder meets qualifying criteria on a continuing basis by way of age, **income level**, veteran status, or disability.

#### Section 4. Severability.

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Town Board of the Town of Montgomery hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

#### Section 5. Repeal.

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

#### **Section 6. Effective Date.**

This Local Law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
