

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 23-2023

AN ORDINANCE AMENDING ORDINANCE NO. 734 “THE MOORESTOWN TOWNSHIP SALARIES AND COMPENSATION ORDINANCE OF 1973,” AS AMENDED AND SUPPLEMENTED, BY ADJUSTING SALARY RANGES FOR SUPERVISORY AND TECHNICAL EMPLOYEES AND CERTAIN PART-TIME EMPLOYEES

BE IT ORDAINED by the Township Council of The Township of Moorestown in the County of Burlington, State of New Jersey, that:

SECTION 1: The “Moorestown Salaries and Compensation Ordinance of 1973,” (Ordinance No. 734) as amended and supplemented, is hereby amended as follows:

A. Section 1(a) is amended to read as follows: The following employees of said Township shall receive an annual base salary within the salary range set forth below:

Assistant Director of Public Works	\$ 100,000 - \$ 125,000
Accountant, Senior & Principal	55,000 - 87,500
Community Development Director	100,000 - 150,000
Confidential Assistant	50,000 - 75,000
Construction Official	95,000 - 140,000
Human Resources Coordinator/Director	75,000 - 98,000
Management Information Systems Coordinator	85,000 - 135,000
Sub-code Officials/Inspectors: Building, Electrical, Plumbing, Fire	75,000 - 110,000
Township Clerk	75,000 - 105,000
Zoning Officer	65,000 - 87,500

B. Section 7 is hereby amended to read as follows:

<u>POSITION</u>	<u>COMPENSATION RANGES</u>
Heavy Laborer – Seasonal	\$15.00 / hr - \$35.00 / hr
Laborer – Seasonal	\$12.00 / hr - \$20.00 / hr
Planning Board Recording Secretary	\$25.00 / hr - \$35.00 / hr
Zoning Board Recording Secretary	\$25.00 / hr - \$35.00 / hr
Recreation Aide	\$11.00 / hr - \$17.00 / hr
Recreation Assistant	\$12.00 / hr - \$35.00 / hr
Recreation Leader	\$11.00 / hr - \$20.00 / hr
Site Supervisor, Asst.	\$25.00 / hr - \$35.00 / hr
Site Supervisor	\$40.00 / hr - \$50.00 / hr

SECTION 2: The above stated annual salaries in Section 1A. are based upon a full-time employee serving in that position. Anyone appointed to a position covered under this section on a part-time basis will be paid based on an hourly rate derived from the salary range stated for that position.

SECTION 3: In all other respects, said Ordinance No. 734, as amended and supplemented shall remain in full force and effect.

SECTION 4: All other ordinances and parts of ordinances and resolutions, insofar as they are inconsistent with any of the terms and provisions of this ordinance, are hereby repealed to the extent of such inconsistency only.

SECTION 5: If any section, paragraph, sentence, clause, phrase, term, provision or part of this ordinance shall be adjudged by any court of competent jurisdiction to be invalid or inoperative, such judgment shall not affect, impair or invalidate the remainder thereof phrase, term, provision or part thereof directly involved in the controversy in which such judgment shall have been rendered.

SECTION 6: This ordinance may be cited as ordinance 23-2023
