**TOWNSHIP OF MOON
ORDINANCE NO. 704**

AN ORDINANCE OF THE TOWNSHIP OF MOON, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 21, PART 2 OF THE MOON TOWNSHIP CODE OF ORDINANCES, STREETS AND SIDEWALKS, TO INCLUDE VARIOUS REVISIONS RELATIVE TO PAVEMENT RESTORATION STANDARDS.

WHEREAS, Section 1506 of the Pennsylvania Second Class Township Code, 53 P.S. §66506, as amended, authorizes the Board of Supervisors of the Township of Moon (the "Township") to "adopt any ordinances, bylaws, rules, and regulations not inconsistent with or restrained by the Constitution and laws of this Commonwealth necessary for the proper management, care and control of the Township and its finances and the maintenance of peace, good government, health and welfare of the Township and its citizens, trade, commerce and manufacturers"; and

WHEREAS, pursuant to Chapter 21, Part 2 of the Moon Township Code of Ordinances, Streets and Sidewalks, as amended, the Township Board of Supervisors has established standards for paving (the "Streets and Sidewalks Ordinance"); and

WHEREAS, the Township Board of Supervisors desires to amend the Streets and Sidewalks Ordinance in order to revise the requirements for pavement restoration.

NOW THEREFORE, the Board of Supervisors of the Township of Moon hereby ordains and enacts as follows, incorporating the above recitals by reference:

Section 1. Section 21-215. of the Streets and Sidewalks Ordinance is amended as follows:

1. Revise Part 2, Section 215 as follows: Add subsection 3, which reads "The Applicant must provide a 1.5" Mill and Overlay from edge of road/back of curb to the centerline. When trenching, a standard one (1) foot cut back on the trench for the binder must be provided. The Applicant will be required to provide a full width mill and overlay if the trench crosses the center-line."
2. Revise Part 2, Section 215 as follows: Add subsection 4, which reads "If the applicant proposes multiple transverse openings of the roadway within 50 feet of each other, measured from the centerline of each trench, the applicant is required to mill and overlay the entire cartway between all proposed openings."
3. Revise Part 2, Section 215 as follows: Add subsection 5, which reads "The applicant or permit holder shall complete restoration in accordance with Township Standards and Details. The applicant or permit holder shall be required to pave/restore/overlay the entire lane or cartway width, as specified herein, for the entire length of the opening plus ten (10) feet longitudinally on each side of the opening in accordance with Township Standards."

4. Revise Part 2, Section 215, subsection 3 to subsection 6.
5. Revise Part 2, Section 215, subsection 4 to subsection 7.
6. Revise Part 2, Section 215 as follows: Add subsection 8, which reads “The applicant or permit holder shall notify the appropriate Township Representative forty-eight (48) hours prior to completing restoration work.”

Section 2. It is the intention of the Township that the chapters, parts, sections, subsections, paragraphs, sentences and/or phrases of this Ordinance are severable. If any chapter, part, section, subsection, paragraph, sentence, or phrase of this Ordinance is for any reason declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or the validity of any remaining chapters, parts, sections, subsections, paragraphs, sentences, or phrases of this Ordinance.

Section 3. All prior ordinances are hereby repealed in whole or in part to the extent inconsistent herewith.

Section 4. This Ordinance shall take effect in accordance with applicable law.
